This Memorandum of Understanding (MoU) entered into and executed on January 14, 2017 between

Indian Council of Medical Research, a Society registered under the Societies Registration Act 1860, having its registered office at, V. Ramalingaswami Bhawan, Ansari Nagar, New Delhi 110029 (hereinafter referred to as 'ICMR' as the context permits)

and

Symbiosis International University, Pune a Deemed University, having its office at Lavale, Pune, 412115, Maharashtra (hereinafter referred to as 'SIU' as the context permits).

Indian Council of Medical Research (ICMR) established in 1911, is an apex body in India for the formulation, coordination and promotion of biomedical research. The ICMR is engaged in conducting and promoting research in various areas of biomedical science through its 32 permanent Institutes/ Centres and Technical Divisions of ICMR Headquarters, using task force approach as well as providing financial assistance to ad-hoc research studies submitted by individual scientists from different parts of the country. The ICMR priorities coincide with National Health Priorities such as control and management of communicable diseases, fertility control, maternal and child health, nutrition and research on major non-communicable diseases like cancer, cardiovascular diseases, diabetes and other metabolic and hematological disorders, mental health research and drug research (including traditional remedies).

Whereas, Symbiosis International University (SIU) was built on the principles of vedic thought of "World as One Family" and is resplendent of the activities and students of several countries. The students come from more than 60 countries and find this to be home away from home. Symbiosis was conferred with the Deemed University status (vide MHRD notification No. F.9-12/2002.U-3 (A) dated 6th May 2002). SIU has been reaccredited by the National Assessment & Accreditation Council (NAAC) with 'A' grade. SIU also has MoUs of collaboration with several renowned universities of the world and encourages students and faculty to participate in its programmes. The Faculty of Health & Biomedical Sciences (FoHBS) at SIU comprising of the Symbiosis School of Biomedical Sciences (SSBS), Symbiosis Institute of Health Sciences (SIHS) & Symbiosis College of Nursing (SCON) and Symbiosis School of Sports Sciences (SSSS) undertake evidence based translational research involving sciences & technology applications for affordable healthcare solutions relevant to the global population. The Symbiosis School of Biomedical Sciences (SSBS) undertakes research in certain broad areas which are of mutual interests with the ICMR viz. stem cell biology, cellular biology, cancer biology, vaccinology, metabolic engineering, clinical biochemistry, nutritive additives, micronutrient deficiencies, food science and product processes, biotechnology, biochemistry, microbiology, infectious diseases, toxicology, reproductive and child health, communicable and noncommunicable diseases, social sciences & mental health.

Whereas, Symbiosis International University (SIU) had entered into a MOU with ICMR for working together to prompte biomedical sciences using facilities and expertise at both places, which MoU was valid for a period of five (5) years with effect from January 23, 2012 till January 22, 2017.



And Whereas, the MoU is due to expire on January 22, 2017 and further as consequence of revision / clarification in Guidelines, Notification issued by UGC/ SIU, relating to Ph.D. Programmes, viz., A) University Grants Commission (UGC) letter D O No F 10-6/2011(PS) Misc. dated 6th July 2015; B) UGC Clarification vide DO NO F10-6/2011(PS) Misc. dated 4th September 2015 and C) SIU Revised Ph.D. Rules, 2015, it is now necessary that changes are effected in the MoU renewal to be implemented with effect from January 23, 2017, to make it consistent to said revision/ clarification in Guidelines, Notification issued by UGC/ SIU;

And Whereas, both parties *viz.* ICMR and SIU are agreeable to enter into a MoU, renewing the MoU dated January 23, 2012 and also, effect changes in the said MoU, arising due to change in law and inclusion of all the thirty-two ICMR institutes and Technical Divisions of ICMR Headquarters.

Whereas, both parties *viz.* ICMR and SIU realize that in the current context, working together is desirable to promote biomedical sciences using facilities and expertise at both the places. Therefore, both parties are agreeable to enter into a MoU for working and cooperating with each other and using their respective expertise, knowledge and resources.

Article I: Principles of Cooperation

ICMR, New Delhi and SIU, Pune agree to develop their academic links especially in the fields of health care, nutrition and life sciences under the principles of mutual understanding, common interest and mutually complementary activities.

- 1. To develop collaboration(s) between SIU and ICMR Institutes as well as Technical Divisions of ICMR Headquarters to promote research in the field of biomedical sciences.
- 2. To promote individual contacts among scholars, students and personnel of both the institutions.
- 3. To provide opportunities for both staff and students to use to maximise the expertise and facilities available in both the organizations through training of students/staff and through exchange of thoughts by brain storming sessions/seminars/workshops and meetings.
- 4. To work jointly for the common research interest at national and international levels. This includes preparation of proposals and their implementation as per the national health priorities.
- 5. To support the exchange of academic, research and training material.
- 6. To share experiences and expertise concerning institute administration and management.
- 7. To encourage any other activities that both the institutions agree to be of mutual benefit such as organizing national/ international conferences and/ or conducting training programmes for skill development *etc*.



Article II: Areas of Cooperation

- 1. Scientists/staff working in ICMR or using ICMR facilities may be enrolled for Master's/Ph.D. programmes that is to be awarded by SIU. The thesis Supervisor will have to be a full time staff member of SIU; scientist(s) from institutes / Centres of ICMR can only be a Co-Supervisor as per recent directives of University Grants Commission, New Delhi. Such Centre needs to have at least two persons with Ph.D. qualification in the area of research and to provide adequate library and lab facilities for research.
- 2. Master's/Ph.D. students working at SIU will be allowed to carry out a part of their research work in ICMR Institutes/ Centres and **vice-versa** depending upon requirements. They may be allowed to use instrument/ facility at the selected ICMR institutes and *vice versa*.
- 3. The employed scientists/ staff from ICMR Institutes/Centres, intending to enroll for Ph.D. programme at SIU will be required to follow all statutory norms laid down by the Competent Authority (UGC) from time to time. However, by virtue of this MOU, these students will avail of certain privileges/ concessions (ref. annexure A).

The aspiring Ph.D. students from ICMR institutes/ Centres will have to go through the Ph.D. Admission Process of SIU. Further, their research proposals will require approval from SIU Institutional Ethics Committee (IEC).

- 4. At the time of thesis submission, the student shall produce evidence to show that he/she has a minimum of two publications (or acceptance of publication) in relevant field in a refereed journal, preferably indexed in Scopus/ PubMed/ Web of Science.
- 5. SIU will grant registration for Ph.D. under the Faculty of Health & Biomedical Sciences in consonance with UGC norms.
- 6. The final copies of the Ph.D. thesis must contain the copyright certificate in the beginning of the thesis, on the left side of the cover page and must mention Indian Council of Medical Research and Symbiosis International University. Patents (if any), originating out of the research output thereof will be jointly credited to both ICMR as well as SIU.
- 7. The employed scientists/ staff from the institutes and Technical Divisions of ICMR Headquarters intending to enroll for Ph.D. programme at SIU will be required to follow all statutory norms laid down by the University as per directives of the UGC/ MHRD, GoI from time to time.
- 8. All Research Publications arising out of the Ph.D. work, by the Ph.D. scholars from ICMR must also mention the affiliation as 'Symbiosis International University'.
- 9. Data generated through such collaborative research will be published in scientific indexed journals jointly with a copyright.
- 10. Scientists of ICMR may deliver lectures in areas of their specialization to students of SIU as Visiting Faculty on days and timings pre-arranged on mutual consent.

- 11. ICMR Institutes/ Centres will provide regular short term project training to the students of SIU in their areas of specialization.
- 12. Once MoU is signed, SIU shall grant, after due consideration of facilities and competencies, recognition to ICMR Institutes/ Centres as Centres for Research Collaborations (CRC) for postgraduate and doctoral studies. It is specifically mentioned that these CRCs are not affiliated to SIU.

Article III: Duration and Termination of the MoU

- 1. This MoU is effective as of the date of signatures by the Authorities of ICMR and SIU.
- 2. This MoU is valid from the date of execution by the Parties and shall remain in effect for FIVE YEARS with effect from January 23, 2017 to January 22, 2022, and thereafter, can be renewed.
- 3. This MoU may be amended at any time by written mutual consent.
- 4. This MoU may be terminated by either party by the provision of written notice of termination not less than six months prior to the desired termination date. However, both parties agree that all continuing obligations to students, staff, funding bodies or other entities are met in full, subsequent to the notice of termination.
- 5. The termination of MOU shall not affect the rights or obligations of either party regarding any binding offer or firm obligation approved and agreed to either party prior to the termination date.
- 6. In the event of any dispute/s arising between the parties hereto, it shall be endeavour of both the parties to first make an attempt to resolve the dispute amicably by mutual discussion and deliberation, failing which the dispute shall be referred to Vice Chancellor, SIU and/or DG, ICMR. The Arbitration shall be conducted as per the provisions of Arbitration and Conciliation Act, 1996. The Arbitral Tribunal shall consist of a sole arbitrator, to be appointed mutually by both the parties. The venue of arbitration shall be Pune. The language of arbitration shall be English. The Award of the Tribunal shall be final and binding on the parties.

Article IV: Miscellaneous

- 1. If any provision of this Memorandum is held by any court or other competent authority to be illegal, void or enforceable in whole or in part, this Memorandum shall continue to be valid as to the other provisions therefore and the remainder of the effected provision.
- 2. Nothing in this MoU constitutes or to be construed a party as the partner, agent employee or representative of the other party. A party must not act independently of the other Party and does not have the right or power to commit the other Party on any matter or incur any obligation on behalf of or pledge the credit of the other Party without the prior written approval of the other Party.

Annexure - A

Background

Symbiosis International University (SIU) had entered into a MOU with ICMR for working together to promote Biomedical Sciences using facilities and expertise at both places. This MOU was signed on January 23, 2012 and was valid for a period of five (5) years i.e. till January 22, 2017. One important aspect of that MoU included permission to the Scientists working in the Institutes and Technical Divisions of ICMR Headquarters to pursue Ph.D. at SIU.

The University Grants Commission (UGC) letter D O No F 10-6/2011(PS) Misc. dated 6th July 2015 has now clarified that only regular teachers of the universities can be appointed as Supervisors for Ph.D. scholar. In further clarification vide DO NO F10-6/2011(PS) Misc. dated 4th September 2015, **UGC categorically states that university cannot utilize the services of Adjunct Faculty as a Ph.D. Supervisor.** Hence, Scientists of ICMR Centres will henceforth not be eligible to function as Ph.D. Supervisors of SIU. They can continue to be appointed as Co-Supervisors. Implementation of this policy will be only with prospective effect. It will not be applicable retrospectively and hence ICMR scientists already having Ph.D. students will continue till the completion of Ph.D. by their students.

Further, as per the current UGC Regulations, SIU rules have been revised, where by committees have been prescribed for approval of Ph.D. presentations. MOU between SIU and ICMR has to be hence amended suitably in sync with these UGC guidelines & above mentioned changes.

The Present Position

SIU issued Rules and Procedures for recognition of the Centre for Research Collaboration (CRC) under Notification No. SIU/ 28/ 648 dated 10th November, 2016. A standard format for MOU has been approved. It is now mandatory for every CRC to sign a formal MoU with SIU.

This MoU is based on now the current UGC regulations and Ph.D. rules of SIU. Under this MoU, following Institutes and all the Technical Divisions of ICMR Headquarters are recognized as the Centres for Research Collaboration (CRC).

Nomenclature: ICMR Centres will henceforth be referred to as 'Centres for Research Collaboration' (CRC) rather than Approved Research Centres (ARC) as it causes some confusion with 'affiliation' which is not permitted by UGC for Deemed Universities.

Whereas SIU is happy to honor the commitments outlined in the previous MoU, in order to abide by the recently issued UGC Regulations and revised Ph.D. guidelines at SIU (in line thereof), certain clauses in the previous MoU will have

to be changed suitably with immediate effect and hence, the new MoU needs to incorporate the following changes:

a. Eligibility and admission process to Ph.D. programme at SIU

- b. Monitoring of the Ph.D. programme by SIU especially insisting on a minimum of two research publications in indexed journals during the course of Ph.D. indicating affiliation of the Ph.D. scholar with SIU.
 - c. Appointment of ICMR Scientists only as Co-Supervisors (refer to clause 1 of article II)
 - d. The role and responsibilities of a Co-Supervisor of SIU is as follows:
 - i. A Co-Supervisor may be inducted initially or subsequently during the research period depending on the need and specialized nature of the research topic.
 - ii. Co-Supervisor will be appointed by the Research and Recognition Committee (RRC) on the recommendation of the Supervisor for providing specialized skill necessary for thesis work.
 - iii. The necessity and precise responsibility of a Co-Supervisor may be determined in each case by the Supervisor in consultation with the scholar. This will become operative on approval by RRC of SIU and written acceptance of the Co-Supervisor.
 - iv. Co-Supervisor is expected to provide subject specific/or methodological support.
 - v. Co-Supervisor will participate in presentations, public defense of the thesis if requested to do so by the Supervisor. Co Supervisors residing outside Pune may join through Skype.
 - vi. Co-Supervisor must be familiar with all SIU Ph.D. related rules and guidelines (attached here with).
 - vii. Co-Supervisor is not required to sign the six monthly progress report of the scholar. However, he / she will sign the final thesis before submission to the University.
 - viii. Co-Supervisor can be nominated as co-author in publications emanating from the thesis depending on his/her contribution to the research work.
 - ix. As the Co-Supervisors are from the institutions not from SIU, the necessary formal approvals from the respective institutions are a prerequisite

Notwithstanding, SIU will continue to offer ICMR candidates the following concessions for the Ph.D. programme:

- a. Normally, Centres for Research Collaboration (CRC) pay a registration fee of Rs. 5000/- annually. ICMR Centres will continue to be exempted from this.
- b. After the candidate has registered online, ICMR candidates can appear for the Ph. D. Entrance Test [PET] (Online / Proctored). Other candidates have to appear in person at one of the four Centres nationally. Appearance for a Ph.D. entrance exam is now mandatory as per the UGC guidelines.
- c. If shortlisted, students have to appear in person for a Personal Interaction. ICMR candidates may be permitted to complete this via skype / video conferencing.
- d. If selected, ICMR candidates will be offered a 50% concession in fees.
- e. Thereafter, selected candidates have to undergo a 240 clock hours (16 credits) Pre Ph.D. course work. Six, credits will have to be at SIU, Pune. ICMR candidates will be allowed to pursue the remaining ten credits at ICMR, provided it is monitored by SIU and certified as per the SIU norms.

f. Co-Supervisor at ICMR will be required to send grades to the Dean Faculty of Health & Biomedical Sciences (FoHBS).

- g. If course work is cleared, the student has to make a Topic Approval Presentation *in person* to Research Advisory Committee. ICMR candidates will be allowed to this on Skype / video conferencing.
- h. ICMR candidates will be allowed to pursue Ph.D. work at the workplace; provided 6 monthly progress reports (in SIU prescribed format), signed by Co-Supervisor from ICMR and Research Supervisor from SIU are sent regularly.
- i. Presentation for mid-term progress review and Pre submission of thesis can be done on Skype / video conferencing.
- j. However, final defense / Viva Voce will have to be done in person at SIU only.
