RISK/ Liquidated Damages In the event of failure or delay on the part of the Contractor to fulfill his obligation in the execution of the order/contract to ICMR-NITM's satisfaction. ICMR-NITM shall have the right to terminate the order/contract and make necessary alternate arrangements for completion of the order/contract through other means at the risk and cost of the contractor. In such an event the earnest money deposit will be forfeited without prejudice to ICMR-NITM's right to claim compensation from contractor for the loss incurred by ICMR-NITM as a result of contractor's failure to fulfill his obligation under the contract/order condition. The contractor shall have no claim for compensation for any loss that may occur from any material he might have collected or engagements, he may have entered into on account of the order/contract.

The contractor shall not assign or transfer any of his rights under the agreement to the other persons. In the event of such transfer of assignment the agreement shall at the option of the Management stand terminated and Security deposit deposited by the contractor shall stand to forfeited.

VI Termination

The Director ICMR-NITM reserves the right for termination of contract in case the services are found to be unsatisfactory and breach of any of terms and condition of contract.

1. The contract can be cancelled at the option of NITM and decision of the Director, ICMR-NITM, Belagavi in this regard shall be binding on the contractor. ICMR-NITM shall recover from the security amount deposited and other dues payable to the contractor on the cancellation of this contract all losses and damages suffered by it, due to non-performance of any of the conditions of this contract by the contractor.
2. If the agreement is terminated by the contractor without giving stipulated period of notice or if he commits any breach of this agreement or fails to observe the

e terms thereof, the security deposit will be forfeited without prejudices to the management's right to proceed against the contractor for any additional damages that the Management suffers as a result of the breach of the conditions under this agreement by the contractor. The Management shall have the right to terminate the agreement at any time in case of any default on the part of the contractor in the matter of compliance with its terms and conditions by giving one month's notice.

VII Arbitration

All disputes and differences arising between the parties in respect of the Contract/WO or breach thereof will be decided by Arbitrator, appointed by Director, ICMR-NITM, Belagavi and the case will be settled as per prevailing guidelines of Indian Council of Arbitration applicable for PSU's. The decision of the Arbitrator in all questions will be final and be binding on both the parties subject to the jurisdiction of the Court of Law at Belagavi, Karnataka.

VIII Penalty

In the event of breach of any of the terms & conditions of the contract, this office shall levy penalty. The contractor is fully aware that any breach of the conditions of this contract causes considerable loss to the company and results in loss of productivity and the penalties shall be levied so as to compensate for the losses that NITM would suffer as a result of breach of conditions of this contract by the contractor.

IX Measure Force

In the event of an order which will be subject to force majeure situation like war, riots or civil commotion, earth quake, flood and other natural calamities, under such situations neither ICMR-NITM nor the contractor shall be considered in default in performance of the work. If the force majeure situation extends beyond 30 days the contractor shall be entitled for time extension to complete the work
