ICMR-NI TM shall recover from the security amount deposited and other dues payables t o the contractor on the cancellation of this contract all losses and damages suff ered by it, due to non-performance of any of the conditions of this contract by t he contractor.
- 2. If the agreement is terminated by the contractor without giving stipulated peri od of notice or if he commits any breach of this agreement or fails to observe th

VII Arbitration

The decision of the Arbitrator in all questions will be final and be binding on both the parties subject to the jurisd iction of the Court of Law at Belagavi, Karnataka.

VII Liabilities Under Laws

I. The contractor shall be solely responsible for complying with provision of the Contract Labour (Regulation & Abolition) Act, 1970 and rules there under and ot her enactment that may be applicable including the Employees Provident Fund & Miscellaneous Provisions Act, 1952 & the schemes (employee's & employer's contribution to be paid by contractor), the Minimum Wages Act, 1948, the Facto ries Act, 1948, Employees Compensation Act, 2010 (formally known as Workme n's Compensation Act, 1923), Employees State Insurance Act, 1948 and Sales T ax Act or any other applicable Laws and the Municipal by-laws or other Statutor y Rules and Regulations what so ever in force, in so far as these are applicable f rom time to time. The contractor must obtain Licence for himself/his firm under the Contract Labour (Regulation & Abolition) Act, 1970 and shall have a Provide nt Fund Code No. and the Employees' State Insurance Act and the scheme, 194 8 Code No. issued by the respective authority.

II. The contractor shall be liable to pay for his employees and employer's contributions under the Employees Provident Fund Act, 1952 / ESIC Act, 1948 and any other statutory Act applicable to canteen staff. The contractor shall pay to his st aff wages not less than the rates prescribed by the Statutory Authority.

III. The contractor shall cover his employees for comprehensive insurance under the Group Personal Accident Scheme or any other such Comprehensive Insuran ce Scheme or any other suitable insurance to cover for any liability as per Empl oyee Compensation Act or any other Act/Rules etc applicable from time to time in respect of his employees. It is however made very clear here that any liability that arises out of the employment of his employees, who are deployed at ICMR-NITM Belagavi, irrespective of whether in course of employment or otherwise, ir respective of whether such liability is statutory or otherwise, will be borne by th e contractor only and HIL shall have no liability whatsoever.

V. The contractor shall not sub-let, assign or transfer the contract given to him t o any other party during the contract period.

VI. Under normal circumstances contract is terminable at one month notice fro m either side. The contractor shall give at least one month notice for terminatio n of contract, extendable by mutual agreement. ICMR-NITM, Belagavi shall have full discretion to recover any loss suffered by it, from the amounts due to the Co ntractor and the amount of Security Deposit pending with ICMR-NITM, Belagavi. The contractor shall also comply with all other Acts and Rules which are applica ble to him or made applicable to him in future and shall maintain all such record s etc. as required under these Acts and Rules.

VII. Contractor have to deposit the returns with the respective Statutory Authori ty ESI, PF, Contract Labour (Regulation & Abolition) Act 1970 or any other applic able act within the prescribed times.

VIII. At the end of each calendar month the contractor shall be required to subm it the following

VIII Penalty

In the event of breach of any of the terms & conditions of the contract, this offic e shall levy penalty. The contractor is fully aware that any breach of the conditions of this contract causes considerable loss to the company and results in loss of productivity and the penalties shall be levied so as to compensate for t he losses that HIL would suffer as a result of breach of conditions of this contract t by the contractor.

IX Measure Force
