Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band defined in relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price.

1. The interested bidders should submit the valid NABL traceability certificate while submitting bid.
2. The interested bidders should upload MSME certificate in the specified tap for purchase /service preference.
3. Interested bidders may inspect the equipment in office hours only.
4. Calibrations should be done before expiry i.e. on or before Jan 2024.
5. The bidders should quote all 1-14 nos. of instruments for calibration.
6. Interested bidders should submit GST certificate while submitting bid in GeM portal.
7. Bidder should sign and put seal on the compliance sheet and same to be uploaded in GeM portal.

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
