# 1. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

#### 2. Generic

**Bidder financial standing:** The bidder should not be under liquidation, court receivership or similar proceedings, should not be bankrupt. Bidder to upload undertaking to this effect with bid.

#### 3. Service & Support

AVAILABILITY OF OFFICE OF SERVICE PROVIDER: An office of the Service Provider must be located in the state of Consignee. DOCUMENTARY EVIDENCE TO BE SUBMITTED.

#### 4. Service & Support

Dedicated /toll Free Telephone No. for Service Support : BIDDER/OEM must have Dedicated/toll Free Telephone No. for Service Support.

#### 5. Service & Support

Escalation Matrix For Service Support : Bidder/OEM must provide Escalation Matrix of Telephone Numbers for Service Support.

## 6. Certificates

## 9. PAYMENT TERMS

9.1 Payment Condition: (a) The cost of services quoted by the Service Provider shall be cover all aspects of service d elivery and include all the components of salary/ wages and taxes, as applicable. (b) The Payment shall be made as per the financial quotes submitted by the Service Provider and accepted by the Buyer.

9.2 Payment Cycle: (a) Payment shall be made once the services are delivered, and the Service Provider submits th e invoice for the same. (b) The Buyer shall make the payment within prescribed timelines as per the payment proce ss flow upon submission of invoice, logbook and service feedback.

9.3 Payment Process: (a) Payment shall be made only after submission of invoices, attendance sheet, logbook, servi ce feedback, non-submission of the same may lead to delay/ deduction in payment. (b) All the penalties/ fine/ intere

st (if applicable) shall be settled before making the payments. Service Provider shall not have any objection on the s ame. (c) Payment shall be made through bank transfer only, in no circumstance cash/ cheque payment shall be mad e.

10. Only service charge in % up to two decimal to be quoted by the service provider. Bidder should quote service ch arges in between 3.85% to 7.00%. Bidder quoting service charges less than 3.85% will be rejected.

11. In case two or more than two agencies quote the same service charges, L-1 will be decided by the GeM Run L1 f eature. However, in absence of Run L1 feature, L-1 will be decided on experience of the agency i.e. the agency whic h has maximum years of experience shall be considered as L-1 in circumstances. In case two or more agencies quot e the same service charge and having same years of experience the L-1 will be decided on turnover of the agency i n the field of providing relevant services in last three financial years. Hence, bidder is requested to submit the overa II along with the turnover in the field of providing relevant services in last three financial years.

12. The Bidder must have successfully executed / completed at least one single order of 80 % of the Estimated Bid V alue or 2 orders each of 50 % of the Estimated Bid Value or 3 orders each of 40 % of the Estimated Bid Value for si milar service(s) in last three years (FY 2020-21, 2021-22 & 2022-23) to any Central / State Govt Organization / PSU / Public Listed Company.
