1. The office of the service provider can be located anywhere in India and documentary proof in this regard must be submitted for at least 6 months prior to the date of floating of the bid and copy of the same should be enclosed in the GeM portal.
2. The Service Provider should submit Registration/incorporation certificate issued by Registrar under Companies Act.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
