If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. Rates: The charges quoted should include the entire facilities require d to render the services without any hidden charges. All costs in the bi d should be expressed in India Rupees without any dependence on exc hange rate, duty or tax structure.

- a) No payment over and above the quoted charges will be made by ICMR-NIE as the Price is inclusive of applicable GST.
- b) **Technical Inspection and performance Evaluation:** ICMR-N IE may carry out a visit to the Bidders premises to assess the lev el of services and facilities etc. & performance evaluation (evalua tion audits (GCP/GCLP) as relevant and determined) of solutions offered during the process of Technical Evaluation or thereafter, i f required.
- c) Payments: Payments for Services will be made by ICMR-NIE mo nthly after completion of the services for the month on submissio n of invoice along with performance reports. Payment will be rele ased after deduction of applicable taxes.
- d) In case of reduction in cost or in ward credit of GST, benefit shall accrue to ICMR-NIE.
- e) **Publicity:** Any publicity by the vendor in which the name of IC MR-NIE is to be used should be done only with the explicit writte n permission of ICMR NIE. If vendor fails to do so, it shall be con sidered a breach of contract.

- j) Results obtained from tests shall be clearly identified on the test reports with the details of tests performed in the laboratory.
- k) The service provider shall at all times ensure that the services b eing provided under the terms and conditions.
- I) The Service Provider shall be fully responsible for the acts of the ir representatives / consultants/ team members and shall fully in

demnify the Buyer for any kind of losses or damages caused by it s team members/ consultants. The Buyer shall not be responsible for any claim from any consultant / team member e mployed by the Service Provider. The Service Provider shall wholly and fully be responsible for any such claims.

- m) All materials (carton boxes, gel pack, data logger) needed for th e transportation should be brought by courier partner identified b y bidder and pick up of samples from the buyer premises.
- n) Pick up Frequency Samples will be picked up on 3 alternative d ays in a week – (Monday, Wednesday and Friday) from MRHRU w hich should reach the testing lab within 24 hrs.
- Sample transportation should include a data logger and the dat a logger sheet should be shared within 3 hours of sample receipt at the laboratory.
- p) All the sample testing report should be shared through the soft ware prescribed by ICMR-NIE.
- q) The charges quoted should include the entire facilities required to render the services without any hidden charges. All costs in th e bid should be expressed in India Rupees without any dependen ce on exchange rate, duty or tax structure.
- r) Bidder should submit the compliance sheet documents.
- s) Bidder shall create a process document for carrying out the Testi ng lab activities and submit the same to ICMR-NIE within 7days o f the award of the contract. This document shall clearly define all the processes to be undertaken by the bidder and standard oper ating procedures (SOP), the processes involved to meet all the re quirements and SLA.

t) Bidder will provide the sufficient resources to fulfil service leve I requirements and availability as defined in this document.

u) Bidder shall have to keep the call records updated with applic able call resolution time details, exclusion etc., for all trial site lo cations in Excel on monthly basis.

v) Escalation matrix shall be given for the staff and other activiti es so that backup supports be available.

w) The selected Company shall not, without ICMR-NIE's prior writ ten consent, disclose the contract, or any provision thereof, of an y specification, plan sample of information furnished by or on be half of ICMR-NIE in connection therewith, to any person other tha n a person employed by the SP in the performance of the contra ct. Disclosure to any such employed person shall be made in con fidence and shall extend only as far as may be necessary for pur poses of such performance.

x) All empaneled companies automatically agree with ICMR-NIE for honor ing all aspect of fair-trade practices in executing the work orders placed by ICMR-NIE.
