1. If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. 3. Copies of relevant contracts / orders to be uploaded along with bid in support of having provided services during each of the Financial year.
4. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. 5. Buyer Added Bid Specific Scope Of Work(SOW)

Text Clause(s)

1. The Candidates should submit self-attested copies of all credentials in support of educational qualifications, age, caste/community, Aadhar Card and affix a colour passport size photograph along with Curriculum Vitae while reporting. **Original Certificates of all these credentials should also be carried with for verification.**
2. The Candidates must fulfill the essential qualification. Mere fulfilling the essential qualification does not guarantee the selection.
3. For reserved category posts, candidates must produce their latest Caste Validity Certificate. OBC candidates must possess a latest valid non-creamy layer certificate. PWD candidates shall produce latest disability certificate issued by a Medical board of Government hospital with not less than 40% disability.
 4. Age relaxation is admissible in respect of SC/ST/OBC candidates, Retrenched Government Employees, Departmental Candidates (including projects) and Ex-Servicemen in accordance with the instructions issued by the Central Government from time to time. Age concession to the extent of service rendered in other ICMR research projects will also be admissible for experienced and skilled persons.
5. Experience certificate should clearly state the nature of work during the period of employment.
6. Candidate must know Tamil Language.
7. The engagement is purely on contract basis and the Director of the Institute reserves the right to dispense with the services of the candidate at any time without assigning any reason.
8. Duration of engagement will be One year.
9. All posts are contractual for the duration offered. The engagement may be renewed after every specific period of time subject to satisfactory performance and project requirement.
10. The engagement will get automatically cease to be on present/extended assignment or completion of the aforesaid project activities, whichever is earlier.
11. No person shall leave the project position, without prior approval of his/her PI and Head of institute. If he/she desires to leave the job, then he/she must submit his/her resignation through his/her PI, one month in advance, indicating specific reasons for not continuing the job. However, the i

institute can terminate the engagement, with immediate effect, by paying one month's notice pay.

12. Condonation of one month notice period can be made on the basis of Permanent Job/Higher Studies/Health Issues with proper justification from the candidate.

13. In case of any contract staff leaving the project position in between the contract period, service provider should provide suitable candidate within a time period of 10 days.

14. He/She will be normally posted at the study site; however, he/she may be temporarily posted to

other study site in the interest of project work.

15. Leave entitlement will be admissible as per rules applicable to the employees of projects under ICMR.

- Annual/Accrued Leave - 30 days per annum (Pro-rated @ 2.5 days per month of completed service.)
- Casual Leave and Restricted Holiday -CL -8 Days & R.H - 2 Days

16. On termination of the contract, they shall not be entitled to any terminal benefit including encashment of un-availed portion of leave.

17. In the event of leave without prior permission of PI/Head of institute and/or any willful unauthorized absence, the contract shall be ceased automatically and the concerned person holding project position will not be permitted to resume duty without prior permission of Head of the institute.

18. Service Provider is required to pay salaries of contracted staff deployed first on their own and then claim payment from the institute along with all statutory documents like, PF, ESIC etc. as well as Pay slip and bank statement of payment done to staff.

19. Salary as mentioned in the advertisement should be paid to the candidates. GST and Service charges/Commission charges will be claimed separately.

20. No certificates will be issued by the institute to the candidates. Only testimonial can be given by the Principal Investigator.

21. Service Provider will be responsible for any administrative issues of the candidate and not the institute.

22. The incumbents selected will have no claim for regular appointments under NIRT/ICMR or continuation of his/her services in any other project.

6. Generic

1. The Seller shall not assign the Contract in whole or part without obtaining the prior written consent of

buyer.

2. The Seller shall not sub-contract the Contract in whole or part to any entity without obtaining the prior written consent of buyer.

3. The Seller shall, notwithstanding the consent and assignment/sub-contract, remain jointly and severally liable and responsible to buyer together with the assignee/ sub-contractor, for and in respect of the due performance of the Contract and the Sellers obligations there under.

7. Payment

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.

14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
