6	Pisonia	20	3	01	Pisonia tree's branches extended upto 10' and surrounded by 4". Around 5 to 6 branches should be cut properly for tree proper standing
7	Samudraphool	30	3	01	Samudraphala tree's branches extended upto 10' and surrounded by 3". Around 7 to 10 branches should be cut properly for tree proper standing
8	Palm	35	3	06	Plam trees branches should be cut properly and remove the coconuts from trees
9	Gulmohar	40	5	01	Gulmohar tree's branches extended upto 10' and surrounded by 3". Around 8 to 9 branches should be cut properly for tree proper standing
10	Suru	40	4	01	Suru tree's branches extended upto 10' and surrounded by 6". Around 5 to 6 branches should be cut properly for tree proper standing
11	Badam	45	5	01	Badam tree's branches extended upto 8' to 15' which goes on Road and surrounded by 4". Around 5 to 6 branches should be cut properly for tree proper standing
12	Badam	40	5	01	Badam tree's branches extended upto

### **TERMS & CONDITIONS**

1. Tenders (**Single Bid** – Technical Bid and Commercial Bid in envelop to be sent together in a single big envelop) should reach **ICMR-National Institute for Research in Reproductive and Child Health, Jahangir Merwanji Street, Parel, Mumbai 400012, Maharashtra** before the prescribed date and time mentioned in the Tender. The tender not submitted as per the above prescribed manner will be treated as invalid.
2. Tender should be superscribed, **Tender for Trimming of Trees** Tender Reference No. NIRRCH/ST/TT/02/ 2022-2023 dated December 30, 2022; Due Date 23/01/2023.
3. All outstation tenders should be sent to so as to reach before the prescribed time limit. Late/delayed Tenders shall not be considered under any circumstances.
4. Tender should be accompanied with Earnest Money Deposit [EMD] for an amount of **Rs. 2,000 (Rupees Two Thousand only)** in the form of Demand Draft drawn in favour of **The Director, ICMR - NIRRCH, payable at Mumbai** and an undertaking wherein it may be stated that 'If they withdraw or modify their bid/s during period of validity etc. they will be suspended as per the directions of competent authority of the Institute'. The offer without EMD would be summarily rejected.
5. The Quantity of the trees / cutting may be increased or decreased at the discretion of ICMR – NIRRCH and payment will be done proportionately.
6. The bidder should have necessary licenses, permissions from local authorities concerned as applicable for the trimming trees
7. The last date for receipt of tenders in NIRRCH is 23<sup>rd</sup> January, 2023 up to 12.00 hrs. The offers received would be tentatively verified on 25<sup>th</sup> January, 2023 at 11.00 hrs.
8. The Director, NIRRCH, reserves the right to call for break-up of the quotation if it is found necessary. Incomplete specifications offered by the tenderer(s) will not be considered and are liable to be rejected.
9. The offers should be kept valid for acceptance for a period up to 30<sup>th</sup> April 2023.
10. The services should be completed in 3 weeks from the date of receiving the confirmed order, unless specified otherwise.

11. The payment will be arranged as per extant Government Rules and Regulations.
  12. The prices quoted shall be firm for the duration of contract period. The tendered price should be quoted as the basic cost, without taxes and duties which may be indicated separately.
  13. Conditional offers will not be accepted and liable to be rejected without any further reference.
  14. The bidder should indemnify ICMR – NIRRCH and its authorities from any liabilities arising from untoward / intentional incidents during the service period / trimming of trees.

The Director, ICMR-National Institute for Research in Reproductive and Child Health (NIRRCH), Mumbai reserves the rights to accept or reject any lowest tender in full or in part of any tender or all tenders without assigning any reasons and cancel the tender at any stage of the tender process.

Any of the disputes if arise between the Supplier/Tenderer and the NIRRCH/ICMR shall be resolved by the sole arbitrator which will be appointed by mutual consent of both the parties thereof failing which one of the Director of other Institute of ICMR in Mumbai (NIIH or NIV) shall be appointed within 30 days from the date of cause of action of dispute and the award as may be given by the sole arbitrator shall be binding on both the parties within the Civil Jurisdiction of Hon'ble High Court of Bombay.
