- 1. The bid is on "As is where is basis" and the buyer shall have to ascertain and get satisfied with conditions of stores before the participation and no complaints what so ever, thereafter will be entertained by the institute.
- 2. The bid shall accompany Registration Fees (Non-refundable) of Rs. 2,000.00 (Rupees Two Thousand only) in the form of Demand Draft drawn in favour of Director, ICMR NIRRCH payable at Mumbai and Earnest Money Deposit will be 10% of the sum quoted by the firm. Quotations without specified Registration Fees and EMD will be summarily rejected.
- 3. EMD is refundable within 30 days from the date of opening of the Tender, in case the tender is not accepted. If the tender is accepted, EMD will be adjusted against payment of allotted lot.
- 4. The balance amount after deducting the EMD already deposited should be paid within two working days from the date of issuance of award letter in the form of Demand Draft drawn in favour of Director, ICMR NIRRCH, payable at Mumbai. The D.D. should be presented to the Section officer (Stores).

- 6. Lot-wise quotations for items (unserviceable equipment / instrument) will only be accepted. Quotations received on lump sum basis will be rejected.
- 7. Successful bidders should make own arrangement of labour and transportation for loading and transporting the material / equipment.
- 8. The successful bidder must deposit the bid value within two (02) working days of its acceptance and lift the stores within two (02) working days from the date of deposit of full value of the stores, offered. The Lot(s) will be allowed to be lifted between 10.00 to 17.00 hours during working days (Mon-Fri) after the auction process is complete in all respects.
- 9. The purchaser must effect complete removal of the Lot(s) from the site within the specified period given in the delivery order issued by the ICMR NIRRCH. - 14. The successful bidder will be the sole custodian of the items after obtaining the administrative approval and financial sanction order.
- 15. The job will be done without damaging the premises / roads / drains etc. The bidder should compensate for the damages, loss etc., in the event of any occurrence. Damages to the extent will be paid by the successful bidder.
