#### **General Instructions**

- 1. This tender document can be downloaded from the website of the ICMR–RMRC, Gorakhpur (https://rmrcgkp.icmr.org.in/) or ICMR (https://main.icmr.nic.in/) or Central Public Procure Portal (www.eprocure.gov.in).
- 2. **EMD**: Interested agencies/firms should submit original Earnest Money Deposit (EMD) amount of `25,000/- and tender document fee (non-refundable) amount of `500/- the form of Bank Draft /DD in favour of "Director, Regional Medical Research Centre" payable at Gorakhpur before last date of bid submission.
- 3. Bids (Technical and Financial Bids) received only in sealed cover will be considered. Bids sent by the agencies without sealed cover will not be considered/rejected.
- 4. The ICMR–RMRC, Gorakhpur will not be responsible for any delay in submitting bids for this tender.
- 5. Bids without requisite tender document fee shall not be accepted. Interested applicants are advised to study the document carefully.
- 6. In case of unsuccessful bidders, EMD will be returned on completion of tender process and no interest will be payable on EMD amount. The EMD of the successful bidder will be returned upon submission of Performance Bank Guarantee. The bids without requisite EMD shall be summarily rejected.

### 7. Performance Bank Guarantee (PBG):

The successful bidder has to submit the Performance Bank Guarantee, detailed as under:

- a) The successful bidder will have to submit Performance Bank Guarantee (PBG) amounting to 10% of contract value within 20 days of award of contract. The PBG shall be valid till the successful completion of the work and extended period of the contract, if any. The PBG deposit shall be in the form of Fixed Deposit Receipt/ Bank Guarantee from a nationalised bank in an acceptable form **in favour of Director, Regional Medical Research Centre, Gorakhpur** and it will remain valid beyond 90 days of the date of completion of work/project.
- b) In case Agency/Firm submits any false information or declaration letter during the tender process or period of rate contract, ICMR–RMRC, Gorakhpur shall invoke the EMD/Performance Bank Guarantee submitted by the bidder, to recover penalty/damages. In case firm/agency fails

to perform/deliver the contract, ICMR–RMRC, Gorakhpur shall invoke the Performance Bank Guarantee to recover penalty/damages.

- 8. Any change/corrigendum in the tendering process of this tender shall be issued through website of ICMR-RMRC, Gorakhpur (<a href="https://rmrcgkp.icmr.org.in/">https://rmrcgkp.icmr.org.in/</a>).
- 9. The ICMR–RMRC, Gorakhpur reserves the right to extend the date/time for schedule of activities without assigning any reason by notifying on its website.
- 10. The bidders are required to submit original as well as duplicate copies of their bids with relevant documents. The bids received in time will be opened in presence of the bidders/authorized representatives who opt to attend, on the scheduled date & time.
- 11. Technical and Financial bids must be submitted separately in envelopes enclosed under a single sealed cover:
  - i) Format for TECHNICAL BID at Annexure VI
  - ii) Format for FINANCIAL BID at Annexure VII
- 12. In case there is any correction, the Bidder shall cut the same neatly and put authorized signature and stamp with date near the place of each correction. Financial bid shall contain only the rate/amount quoted after discount offered and no other conditions whatsoever. The bidder shall indicate the prices/rates as specified in the Financial Bid format given at **Annexure-VII**. Any conditions given in this part shall not be considered and may render the offer liable for rejection.

### 13. Pre-Bid Conference Enquiries and Clarifications

The ICMR–RMRC, Gorakhpur will host a Pre-Bid Conference of prospective bidders as per the schedule mentioned at **page no 2 of Tender**. The representatives of the interested company/Firm may attend the pre-bid conference at their own cost. A maximum of 2 representatives of each prospective bidder shall be allowed to participate in pre-bid conference. In respect of clarifications sought, the following shall apply:

- a) The ICMR-RMRC, Gorakhpur reserves the right not to consider any changes/suggestion in the tender's terms & conditions that is found unacceptable.
- b) If in the opinion of ICMR–RMRC, Gorakhpur, certain conditions are acceptable, in whole or in part, the same shall be incorporated as such.
- c) The venue for the pre-bid conference is mentioned below:

- d) The Pre-Bid conference may be scheduled *via* phone or video call in case the bidder is not able to join physically if deemed suitable by the ICMR–RMRC, Gorakhpur
- 14. The bid shall be signed by a person legally authorized to enter into contract on behalf of the Bidder. The Bidder shall submit Power of Attorney in favour of the person who is authorized to enter into contract/agreement on behalf of the Bidder. ICMR–RMRC, Gorakhpur will not be bound by any Power of Attorney granted by the Bidder or changes in the Constitution of the firm made subsequent to submission of the bid or after the award of the contract.
- 15. Financial bids will be opened only of those firms which qualify technical bid criteria.
- 16. **Resolution of disputes:** The ICMR-RMRC, Gorakhpur and the Bidder shall make every effort to resolve any issue amicably, by direct informal discussion between the respective Authority of ICMR–RMRC, Gorakhpur and the Bidder, any case of disagreement or dispute arising between them under or in connection with the Contract.
- 17. **Applicable Law:** The contract, including all matters connected with this Tender, shall be governed by the law of the Union of India, both substantive and procedural, for the time being in force and shall be subject to the exclusive jurisdiction of Gorakhpur or Uttar Pradesh, if required.
- 18. **Negotiations**: Negotiations if considered necessary, shall be held only with the selected Firm/Agency who shall be placed as **L-1**. Under no circumstances, the financial negotiation shall result into an increase in the price originally quoted by the Agency/Firm. Date and Time for negotiation shall be communicated to the Firm/Agency. Representatives conducting negotiations on behalf of the agency must have the written authority to negotiate and conclude the contract.
- 19. The Director, ICMR–RMRC, Gorakhpur reserves the right to award the contract/work/cancel without assigning any reason. In case of differences, if any, the decision of the Director, ICMR–RMRC, Gorakhpur shall be final.

Interested bidders should submit the duly sealed bids complete in all respect to **Tender Drop Box** kept in the **Administrative Block** of the **ICMR–RMRC**, **Gorakhpur** or by post on or before last date and time of bid submission.

Sealed Cover of the Bid Documents should be superscribed as "Tender for supply of books/periodicals for the Library of ICMR-RMRCGKP"

### INSTRUCTIONS FOR BID SUBMISSION

- 1. Interested Bidders are requested to download Tender document from the website of the ICMR–RMRC, Gorakhpur (www.rmrcgkp.icmr.org.in) or ICMR (https://main.icmr.nic.in/) or Central Public Procure Portal (www.eprocure.gov.in).
- 2. Bidders are advised to register their valid e-mail ID, address for communication and mobile numbers as a part of the Bidding process.
- 3. The intending tenderer, in case of Authorized Distributor/ Authorized Dealer shall possess valid authorized Distributorship /Dealership license and/or Authorization Letter of Government for Supply of Books or any similar document. The tenderer shall enclose the copy of the same along with technical bid while submitting the bid documents.
- 4. The books/periodicals listed in **Annexure VIII** shall be in compliance with the terms & conditions/ specifications mentioned in **Annexure III** & **Annexures VI** & **VII** of the tender and shall be of the best quality and high standards.
- 5. While submitting the tender, if any of the prescribed conditions are not fulfilled or are incomplete in any form, the tender is liable to be rejected.
- 6. The Technical Committee constituted by the Director, ICMR–RMRC, Gorakhpur shall have the right to verify the particulars furnished by the bidder independently.
- 7. Tenderer shall take into account all costs including delivery of material at the designated place of ICMR–RMRC, Gorakhpur while quoting the rates. In this regard no claim of any extra payment for any reason shall be entertained.
- 8. The items should be carefully packed in water proof packets and the supplier shall be responsible for any damage or lost during the transit of items.
- 9. All the bid documents should be as per the instructions and terms & conditions of tender.
- 10. All the communications with respect to this tender shall be addressed to: The In-charge Library, ICMR-Regional Medical Research Centre, Gorakhpur, Uttar Pradesh–273013.
- 11. Bidders should take into account any corrigendum published on the tender document before submitting their bids.

- 12. Bidders should go through the tender advertisement and the tender document carefully to understand the documents required to be submitted as part of the bid. Any deviations from instructions may lead to rejection of the bid.
- 13. Required Original documents should be posted/submitted latest by the last date of bid submission or as specified in the tender documents.
- 14. The format for Technical Bid and Financial Bid (**Annexure –VI & Annexure VII**) have been provided with the tender document to be filled by all the bidders. Bidders are requested to note that they should necessarily submit their bids in the format provided and no other format is acceptable.

# Terms & Conditions and Preparation of Bids

- The bidders may submit duly filled and completed bidding document as per the instructions mentioned in the tender/bidding documents. Incomplete bid shall be rejected. The conditions of tender shall be governed by the details contained in complete bid document.
- 2. The Rate/Amount quoted ( `) after discount should be as per the format which includes Taxes/GST, if any.
- 3. The Bidder shall not tamper/modify price bid format in any manner. In case the same is found to be tempered/ modified in any manner, tender will be completely rejected and EMD would be forfeited and tenderer is liable to be banned from doing business with the ICMR/RMRC, Gorakhpur.
- 4. The Firm/Agency should preferably be a member of the Federation of Publishers and Book Sellers Association of India and a proof has to be enclosed in the Technical Bid. Preference will be given to the regular/affiliated members.
- 5. The firm must also possess valid GST Registration Number and a copy of the same must be submitted with Technical Bid. The firm should be having PAN (Permanent Account No.), TAN allotted by the Income Tax Department and documentary proof of the same has to be enclosed along with the technical bid.
- 6. The firm should have financial status in dealing with the supply of the books/periodicals. Turnover of the firm should be minimum Rupees Ten Lakhs only (`10,00,000/-) per annum. The documentary proof of this effect for each year for the last three years has to be enclosed along with the offer of the tender, failing which the offer will be rejected (to be enclosed with the Technical Bid).
- 7. Interested agencies/firms should submit Earnest Money Deposit (EMD) amount of `25,000/-and tender document fee amount of `500/- in the form of Bank Draft /DD in favour of "Director, Regional Medical Research Centre" payable at Gorakhpur. (Tender fee non-refundable) before last date of bid submission. Name of the Tenderer and Tender reference number has to be furnished on the back of the Tender Fee /EMD Demand Draft/Bank Draft. The envelope containing EMD Demand Draft should be superscribed with "EMD for Tender for supply of the books/periodicals".
- 8. The Firms who are registered with MSME/NSIC with valid certificate duly issued by the Government of India may be exempted for submitting Earnest Money Deposit (EMD). Bidders should submit supporting documents for EMD exemption.

- 9. The EMD will be returned to the unsuccessful bidders after the orders are placed with the successful bidder/bidders. The EMD will be forfeited if the bidder fails to accept the order based on its offer/bid or fails to supply the items.
- 10. a) The successful bidder will have to submit Performance Bank Guarantee (PBG) amounting to 10% of contract value within 20 days of award of contract. PBG shall be valid till the successful completion of the work and extended period of the contract, if any. The PBG deposit shall be in the form of Fixed Deposit Receipt/ Bank Guarantee from a nationalised bank in an acceptable form in favour of **Director**, **Regional Medical Research Centre**, **Gorakhpur** and it will remain valid beyond 90 days of the date completion of work/project.
  - b) In case Agency/Firm submits any false information or declaration letter during the tender process or period of rate contract, ICMR–RMRC, Gorakhpur shall invoke the EMD/Performance Bank Guarantee submitted by the bidder, to recover penalty/damages. In case firm/agency fails to perform the contract, ICMR-RMRC, Gorakhpur shall invoke the Performance Bank Guarantee to recover penalty/damages.
- 10. **Signing of contract**: The successful bidder shall mandatorily enter into a **Service Level Agreement (SLA)** with ICMR–RMRC, Gorakhpur, within 20 days of the award of the work order.
- 11. The vendor must be Certified/Authorized by the Government of India to supply books. The vendor should provide relevant documents along with the Technical Bid.
- 12. The Firm should have at least two orders of minimum of `2,00,000 (Rupees Two Lakhs) for supply of books/periodicals/journals to Govt. Institutions/Libraries/Public Sectors Undertakings/Autonomous Organizations/ private bodies to which they have supplied books/periodicals in the last three years along with proof.
- 13. All the Books/periodicals/journals/subscriptions shall be supplied with an authentic price proof.
- 14. Bidders should provide an Undertaking on non-judicial stamp paper that publishers/suppliers have been not blacklisted by any State/Central Government State/ Central Government departments/other organizations. An undertaking will be submitted along with Technical Bid.
- 15. In case order is placed then supplier shall append the declaration on the bill that only the latest editions of the books/periodicals *etc.* have been supplied. Old editions may be accepted if specifically mentioned/required or when new editions are not available (with proof). In case of any doubt, lack of information or discrepancy in the books/periodicals list, the bidder/supplier

- may consult the concerned authority as indicated in the Tender document before placing the order.
- 16. Any Supplier found to have cheated by providing old or fake books/defaulted in supplying required Books even on extended time limit without reasonable grounds, will be liable for blacklisting besides imposition of penalty to the tune, ICMR-RMRC, Gorakhpur may deem fit.
- 15. Liquid Damage Charges: If the supplier fails to deliver any all the books/periodicals/journals/subscriptions within the time/period(s) specified in the contract, the purchaser shall, without prejudice to its other remedies under the contract, deduct from the contract price, as liquidated damages, a sum equivalent to 0.5% (half percent) of the delivered price of the delayed goods for each week of delay or part thereof until 10% (ten percent) of the delayed goods' contract price. Even the purchaser may consider termination of the contract for inordinate delay.
- 16. Further, in case of delay in supply as above mentioned, the supplier, notwithstanding any stipulation in the contract for increase in price for any ground, shall not be entitled to any increase in price and cost, whatsoever, which take place during the period of delay. But, nevertheless, the purchaser shall be entitled to the benefit of any decrease in price and cost on any ground during that period of delay.
- 17. In case of cheating by charging more than actual Publisher's Price, the Firm can be punished by blacklisting/forfeiting the EMD and deductions in bill along with penalty.
- 18. Bidders are required to submit their response in two parts **Technical Bid (as per Annexure V)** & **Financial Bid (as per Annexure VI)**. Firms not adhering to this will not be considered for further processing of their proposals.
- 19. Financial Bid of the Tender Document should mention the Amount quoted after discount by the bidder and should be duly signed and stamped by the bidder.
- 20. Financial Bids of those Bidders who fulfilled Technical Bid conditions mentioned in the Tender document will be considered for opening of their Financial Bids.
- 21. The Amount quoted after discount by the bidder in the Financial Bid should be inclusive of all levies and charges for packing, forwarding, freight and insurance *etc.* in case of books/periodicals/journals/subscriptions to be supplied.
- 22. Bid will remain valid up to 90 days.
- 23. If order placed, then supplier shall supply all the ordered books within the period (20 days for Indian Publication and 90 days for Foreign Publication) from the date as specified in the purchase

order. If the supply is not received within the stipulated time, the ICMR-RMRC, Gorakhpur reserves the right to cancel either the entire order or part thereof without any further notice/reminder. In case, the supplier needs some more time for supply, he/she should seek in writing on sound grounds, further time from the concerned officer at least before supply date expires.

- 24. The ICMR–RMRC, Gorakhpur may empanel more than one supplier/publisher and shall be free to purchase books/periodicals through any one or more of them. However, the act of empanelment shall not deprive the Centre of its right to purchase books directly without routing them through the empanelled agencies.
- 25. The Director, ICMR–RMRC, Gorakhpur is not bound to place single order for all books/periodicals/journals/subscriptions. Different orders may be placed for different books on the basis of competitive Bids. Decision of the Director, ICMR–RMRC, Gorakhpur will be final and binding in all aspects. Suppliers/Firm that can provide maximum enlisted books will be preferred. The Director, ICMR–RMRC, Gorakhpur may modify/relax any terms & conditions in this tender as deemed suitable to complete the procurement process in good faith or in the public interest.

### **Additional Terms and Conditions to Bidders**

### In case of successful bid, bidder(s), should ensure that –

- 1. Only the latest editions of the books *etc.* need to be supplied unless specifically mentioned.
- 2. The actual prices of Publications have been quoted without any handling/postage charges.
- 3. There should not be any remaindered titles/ damaged books with missing pages.
- 4. Damaged books/periodicals, books with missing pages shall have to accept back by the supplier even after they have been stamped for accessioning.
- 5. If in case of award of contract, Supplier found to have cheated by supplying old and remaindered books and defaulted in supplying books even on extended time limit without reasonable grounds, will be liable for blacklisting besides imposition of penalty to the tune ICMR–RMRC, Gorakhpur may deem fit.
- 6. In case of cheating by charging more than actual Publisher's Price, the Firm may be punished by blacklisting/forfeiting the EMD/ PBG.
- 7. The Firm/Agency should preferably be a member of the Federation of Publishers and Book Sellers Association of India or any other affiliated agency and a proof has to be enclosed in the Technical Bid.
- 8. The Firm/Agency should give undertaking that the firm have necessary permissions to deal with foreign and Indian books supply / subscription and make necessary payment in Indian currency.
- 9. Price should be quoted preferably for indigenous items. In case any imported items are quoted it should be specified and be quoted in Indian currency and the detailed terms and conditions of import of such items should be indicated.
- 10. All books/periodicals should carry a discount as per the agreed terms.
- 11. If a book/periodical is ordered from abroad, this office should be informed accordingly before sourcing it.
- 12. The latest paperback editions should always be supplied unless otherwise mentioned. Indian reprints/editions, if available should be supplied. In-charge Library, ICMR–RMRC, Gorakhpur

should be consulted beforehand if vendors intend to supply hardback editions, if the ordered paperback edition is not available. In case of any doubt, lack of information or discrepancy in the book/periodical list, the bidder/supplier may consult the concerned authority as indicated before placing the order.

- 13. The Supplier shall supply all the ordered books/periodicals within the period (20 days for Indian Publication and 90 days for Foreign Publication) from the date as specified in the purchase order.
- 14. This order would be treated as cancelled, if the books/periodicals are not supplied or no report as to availability or otherwise is received within specified period.
- 15. There should be no hidden charges once the successful bidder enters into contract Agreement with ICMR–RMRC, Gorakhpur. The ICMR-RMRC, Gorakhpur will not be liable for payment of any such tax/charge which remained undisclosed in the financial bid by the bidder.
