| S.N. | QUERIES OF AGENCIES | CLARIFICATION |

| 01 | What is the percentage of service charge applicable for DGR services? | Service charges for all cases sponsored 13th May 2021 onwards will be at 10% (fixed) till migration of DGR Security Schemes to GeM Portal. |
| 02 | What is the percentage of deposit amount for Bank Guarantee? | Bank Guarantee should be up to a maximum limit not exceeding 10% of one month's wage bill. |
| 03 | As per DGR, which area rates to be quoted (A, B or C) for pune? | Pune city comes under 'A' category area. |
| 04 | Is ESIC applicable or not? | <p>The employees employed in the watch & ward duties shall be covered under the Employees State Act 1948 as amended from time to time based on the gazette notifications by respective State Governments covering the areas under the ESI Act. Those areas which are not covered in the notification shall be covered under the Workmen Compensation Act 1923, as applicable.</p> <p>The ESI scheme is applicable to all factories and other establishments as defined in the Act with 10 or more persons employed in such establishment and the beneficiaries' monthly wage does not exceed Rs. 21,000 are covered under the scheme.</p> |
| 05 | Is minimum experience mandatory for DGR sponsored security agencies? | DGR Sponsored security agencies do not require minimum experience, minimum turnover and charges for tender documents. |
| 06 | When the Labour Licence is to be submitted ? | Labor license will have to be submitted after awarding the contract. |
| 07 | What is the criteria for calculation of EPF? | Both employee & employer contribute equivalent to the ceiling limit of 15000. |
| 08 | What will be the maximum bonus ? | Bonus is mandatory as per Payment of Bonus Act 1965 (as amended vide payment of bonus Amendment Act 2015), concerned month's wage as fixed by DGR (8.33% per month on Basic+VDA) Or State Govt. Or Rs.7000/- whichever is higher is payable to the security guard / supervisor w.e.f. 01 April 2014. |
