Terms & Conditions:

1. Quotation for the requisite items (list attached), addressed to the "Director, ICMR-National Institute of Cancer Prevention and Research, I-7, Sector-39, Noida" should be submitted to Stores-In-Charge, Stores Section, NICPR, NOIDA, latest by 26.04.2022 till 5 PM.
2. Only sealed quotation will be considered.
3. Kindly mention the subject "Chemicals & Other items (MRHRU-11 items)" & [due date], on the top of envelope.
4. Quotation received after the last date and time or not in provided format is liable to be rejected.
5. Quotation should have a minimum validity of 03 Months.
6. Quotation should have the file reference number as mentioned above.
7. The quotation is to be submitted only in the format enclosed. Not acceptable in any other form.
8. Price should be quoted on the Vender's Letter Head, duly stamped and signed.
9. In the quotation, Sl. No. and name of the items should be same as per the format enclosed.
10. It is mandatory to indicate the GST number in Quotation as well as in the bill for our information.
11. GST will be applicable as per Gol norms to ICMR-NICPR, Noida. Rates may be quoted with GST@5% against the GST/DSIR Certificate.
12. Quotation should be preferably, typewritten and every correction in the quotation should invariably be signed by the bidder, failing which, the quotation is liable to be rejected.
13. The bidder conditions mentioned in the quotation shall not be binding on ICMR-NICPR, Noida.
14. Vendors may be asked to provide sample of goods/reagents/plastic ware/kits for quality/compatibility before accepting the order. In case the goods are not in conformity with the quality, the order shall stand cancelled.
15. Any dispute concerning any Terms and Conditions of the Quotation and/ or the supply of items, will be subject to Delhi Jurisdiction only.
16. Materials should be delivered within **Four Weeks** at ICMR-NICPR, Noida from the date of issue of purchase order. The liquidated charges @ 0.5% per week shall be imposed if supply made after expiry of delivery period subject to maximum 10% of the total value of goods/ contract value.
