2. Only sealed quotation will be considered.
3. Kindly mention the subject "**Chemicals & Other items (MB-WMS-4 Sample)**" & [due date], on the top of envelope.
4. **Quotation received after the last date and time or not in provided format is liable to be rejected.**
5. Quotation should have a minimum validity of 03 Months.
6. The bidder should clearly mention whether they are Manufacture or authorized Dealer/ Agent/ Distributers/ Suppliers of the Manufacturer. In the case of Dealer/ Agent/ Distributers/ Suppliers, valid authorization letter from the Manufacturer address to Director, ICMR-NICPR, Noida should be submitted along with the quotation.
7. Quotation should have the file reference number as mentioned above.
