- 2. Only sealed quotation will be considered.
- 3. Kindly mention the subject <u>"Chemicals & Other items (MB-WMS-4 Sample)</u>"& [due date], on the top of envelope.
- 4. Quotation received after the last date and time or not in provided format is liable to be rejected.
- 5. Quotation should have a minimum validity of 03 Months.
- 6. The bidder should clearly mention whether they are Manufacture or authorized Dealer/ Agent/ Distributers/ Suppliers of the Manufacturer. In the case of Dealer/ Agent/ Distributers/ Suppliers, valid authorization letter from the Manufacturer address to Director, ICMR-NICPR, Noida should be submitted along with the quotation.
- 7. Quotation should have the file reference number as mentioned above.
- 8. The quotation is to be submitted only in the format enclosed. Not acceptable in any other form.
