1	Supply & installation of 75mm thk, Bison Panel of size 2400/2700/3000 mm length and 600 mm wide made up of two fibre reinforced cement of a light concrete core and having Tongue & Groove joint system for walls and partitions using G.I. Floor channel & ceiling channel, hard ware, jointing compound, bison panels are joined with Acrylic putty & mess tape on Tongue & Groove joints for an approximate area of 360 Sq.ft.
2	Providing and fixing aluminium work for partitions with extruded built up standard tubular sections of size 50x50mm with fixing with dash fastenes/ screws required dia and size, including necessary filling up the gaps at junction's sides. Aluminium sections shall be smooth, rust free, straight, mitred and jointed mechanically wherever required including cleat angle, aluminium snap beading for glazing / panelling with stainless steel screws, all complete as per requirement.
