(i) Website Design and Development

Specifications required –

- 1. Website will be a combination of static and dynamic pages (at least four dynamic pages, at least four static pages).
- 2. The design should be optimizable for all devices desktops, laptops, tablets and mobile phones (Windows, Android and iOS).
- 3. Contact information along with a contact form must be designed, with an integration of an email notification when the form is submitted
- 4. Support the website with a Control Panel and a Content Management System to manage updating of content and hyperlinks, uploading media in the form of videos, documents and photos, optimizing the metadata for Search Engine Optimization.
- 5. Set up social media links. Add social media widgets on the website to automatically reflect the updates on them

- Tenders (Two Bids Technical Bid and Commercial Bid in separate envelops to be sent together in a single big envelop) should reach ICMR-National Institute for Research in Reproductive and Child Health, Jahangir Merwanji Street, Parel, Mumbai 400012, Maharashtra before the prescribed date and time mentioned in the Tender.
- 2. Offer can be quoted separately i.e., Website & Software. Bids / Quotations only for either Software / Website will be accepted if the requirement is met.
- 3. The tender not submitted as per the above prescribed manner will be treated as invalid.
- 4. All outstation tenders should be sent to so as to reach before the prescribed time limit. Late/delayed Tenders shall not be considered under any circumstances.
- 5. Tender should be accompanied with Bid Security Declaration (in lieu of Earnest Money Deposit [EMD]), wherein it may be stated that 'If they withdraw or modify their bid/s during period of validity etc. they will be suspended as per the directions of competent authority of the Institute'. The offer without Bid Security Declaration would be summarily rejected.

- 7. The successful tenderers will have to submit Demand Draft / Bank Guarantee in favour of Director, NIRRCH, equivalent to 3% of the order value/contract cost (towards security of performance), which will be retained till the completion of warranty period, starting from date of successful installation and testing of Equipment. The Director reserves the right to exempt from said submission in case of low value orders.
- 8. The maximum response time to attend any glitches in the software / website would be 48 hrs. 0.1% of Basic Cost as penalty per week till the problem / glitch is attended.
