## Chapter 2 : TERMS AND CONDITIONS OF TENDER

1. **Tenders (Single Bid – Techno-Commercial Bid) should reach ICMR-National Institute for Research in Reproductive Health (ICMR-NIRRH), Jehangir Merwanji Street, Parel, Mumbai 400012, Maharashtra before the prescribed date and time mentioned in the Tender.** In case hard copy cannot be issued, soft copy may be mailed to **stores@nirrh.res.in, nirrhequip@gmail.com.**
2. Conditional offers will not be accepted and liable to be rejected without any further reference. The Director, ICMR-NIRRH reserves the right to call for break-up of the offer, if necessary.
3. The tender not submitted as per the above prescribed manner will be treated as invalid. All outstation tenders should be sent to so as to reach before the prescribed time limit. Late/delayed Tenders shall not be considered under any circumstances.
4. Tenderer are advised to visit the place of work for assuring the nature and volume of work realistically before quoting the rates. Accordingly, the **agency/contractor may make necessary site visit (on any working day from 04<sup>th</sup> to 08<sup>th</sup> October, 2021; between 2.00 PM to 4.00 PM).** In case of any query during the site visits, the same may please be put up in email (stores@nirrh.res.in / nirrhequip@gmail.com) and the same would be addressed immediately.
5. The last date for receipt of tenders in ICMR-NIRRH is **11<sup>th</sup> October, 2021** up to **17.00 hrs.** The offers received would be verified on **13<sup>th</sup> October, 2021 at 11.30 hrs.**
6. **Award Criteria & Right to accept any bid and to reject any or all Bids:**
  - The Director, ICMR-NIRRH reserves the right to accept or reject any tender, or cancel/ withdraw invitation to tender for any reason and annul the tender process and reject all tenders at any time prior to the award of Contract, without thereby incurring any liability to the affected Bidder or Bidders.
  - The Director, ICMR-NIRRH shall not be bound to accept the lowest or any bid and reserves to itself the right of accepting whole or a portion of any of the bid as it may deem fit, without assigning any reason thereof.
  - Canvassing in any form or any approach to official or otherwise, by the tenderer to influence the consideration of his tender shall render the tender liable to be summarily rejected.
  - The award of contract would be to the successful tenderer whose tender has been determined to be substantially responsive and to be the lowest evaluated bid, further provided that the tenderer is determined to be qualified to perform the contract.
7. The selected agency / contractor will enter into an agreement on the non-judicial stamp paper within 10 working days after award of work/tender.
8. **Tender should be accompanied with Bid Security Declaration (in lieu of Earnest Money Deposit [EMD]), wherein it may be stated that ‘If they withdraw or modify their bid/s during period of validity etc. they will be suspended as per the directions of competent authority of the Institute’. The offer without Bid Security Declaration would be summarily rejected.**

- 9. The agency / contract will be awarded for a period of 12 months initially which can be further extended up to 24 months, if mutually agreed upon.**
10. The successful tenderer will have to submit Demand Draft / Bank Guarantee in favour of Director, ICMR-NIRRH, equivalent to 3% of the order value/contract cost (towards security of performance), which will be retained for a period of 60 days beyond the completion of contract period.
11. The offers should be kept valid for acceptance for a period up to **11<sup>th</sup> January, 2022**.
12. The payment will be arranged as per extant Government Rules and Regulations. The payment of contract charges will be made on quarterly/half yearly basis. The contractor shall submit the bills, with copies of attendance with necessary certification of competent authority of the Institute.
13. The agency / contractor shall provide necessary facilities and conveyance for work performance of their staff. The agency / contractor should provide necessary tool kits and mobile phones to the concerned manpower.
14. In case of any misconduct or delay in discharging duties or if the performance is not found satisfactory, on the part of any personnel employed by the contractor his service shall be terminated with an advance notice of one month.
15. Corrupt, Fraudulent, Collusive or Coercive Practices:  
It is expected from the tenderer that they will observe the highest standard of ethics during the procurement and execution of such contracts. In pursuance of this policy:  
(a) for the purpose of this provision, the terms set forth below shall mean as under:  
(i) "Corrupt practice" means the offering, giving, receiving or soliciting, directly or indirectly, of anything of value to influence the action of a public official in the procurement process or in contract execution; and  
(ii) "Fraudulent practice" means a misrepresentation/ omission of facts in order to influence a procurement process or the execution of a contract.  
(iii) "Collusive practice" means a scheme or arrangement between two or more Bidders, with or without the knowledge of the Purchaser, designed to establish bid prices at artificial, non-competitive levels; and  
(iv) "Coercive practice" means harming or threatening to harm, directly or indirectly, person or their property to influence their participation in a procurement process or affect the execution of a contract;  
(b) A Bid may be rejected by the Purchaser if it is determined at any stage that the respective Bidder has engaged in corrupt, fraudulent, collusive and coercive practices as mentioned above in competing for the contract in question.
16. Any of the disputes if arise between the Tenderer and the NIRRH/ICMR shall be resolved by the sole arbitrator which will be appointed by mutual consent of both the parties thereof failing which one of the Director of other Institute of ICMR in Mumbai (NIIH or NIV) shall be appointed within 30 days from the date of cause of action of dispute and the award as may be given by the sole arbitrator shall be binding on both the parties within the Civil Jurisdiction of Hon'ble High Court of Bombay.

**Rodent Control:**

- Inside the premises control by glue-pad and rat catch cages.
- Outside the building premises by baiting and placing rodabox.
- To stop the entry by the hanging cables and pipelines by cap fitting.
- The services of bait, glue pad should be provided fortnightly (15 days interval).
- One-time cap fitting for cables and pipelines.
- Set up of rodaboxes to be installed outside the premises; One time and subsequent services every 15 days.

**General Pest Control:**

- By way of spray and gel to control the crawling insects such as spider, cockroach, lizard, ants, silver fish etc.
- Anti-termite by way of drilling and spray.
- To control wood borer by way of injecting and oil based spray.
- Chemicals or materials are to be used for pest control services should not harm of animal's daily cycle and it will not affect any problem in Animal House area.
- Specification and make/quality of chemical/pesticides shall be clearly spelt in the offer/tender, and it should be certified by WHO Pesticide evaluation scheme (WHOPES) for public health utilization and approval with BIS certification.
- Agency will be 100% responsible to control rodents
- Dead rodents will be removed from the inside of building/ false ceiling/ ducts etc.

**Frequency:**

- Frequency of general pest control at residential quarters will be quarterly and the office premises on monthly basis.
- One major treatment for period of One year and 3 follow ups with guarantee period One Year.

**Other Conditions:**

- The tenderer shall also furnish the 24 HRS Helpline telephone / Mobile numbers and email address, on which they can be contacted, for any service requirements. It will be imperative for the firm to do attend the urgent calls within 48 hours from the time of informed received by the company by any means of communication including telephone.
- If the area covered under this service contract is not provided pest control services for more than one week, the contract fee will be deducted for this period, the amount of penalty would be ₹500/- per day per complaint for the period of delay in excess of seven days, besides that any other administrative action will be initiated as deem fit.

**Important Eligibility Criteria:**

- The agency should be Indian Pest Control Association (IPCA) Member.
- Agency should be registered with NSIC and MSME.
- The agency should have ISO9000 Certification.
- The agency should be registered with Municipal Corporation of Greater Mumbai (MCGM).
- The Tenderer shall have at least three years of similar job experience for the similar type of work in the hospitals/health care centers/ Government/Semi-Govt. Organizations/any private hospitals.
- The firm having experience maintaining Pest Control Services in any Central/State Govt. Dept., PSU's, Autonomous Bodies, Large Industrial/Educational Campus/corporate Super Specialty Hospitals will be preferred.
- The tenderer should have qualified technical personnel to handle the equipment quoted and shall provide a list of service Engineers with the copy of Identity Cards, who will be deputed for the maintenance job.
- The agency shall be absolutely responsible for the payment of salary, and all other statutory obligations for the workers employed on account of wages bonus, arrears, employment, termination benefit, compensation or other claim whatever and ICMR-NIRRH shall have no connection in relation to such matters.
