CORRIGENDUM

With reference to this Institute's Tender Notice No. NIIRNCD/E/ST/Vendor Registration/2021-22 dated 07.07.2021, following amendemnets are issued:-

Para-3.3 In terms of Para-4 of Deaprtment of Expenditure's OM No. F.9/4/2020-PPD dated 12.11.2020; all Bidders are exempted from submission of the Bid Security/Earnest Money Deposit. Accordingly, bidders may submit the "**Bid Security Declaration**" in the prescribed format given in Annexure-IV in place of Bid Security/Earnest Money Deposit.

Para-3.4 All Bidders shall have to deposit the **Bid Security Declaration except** Micro and Small Enterprises (MSEs) as defined in the MSE Procurement Policy issued by Department of Micro, Small and Medium Enterprises (MSME) or are registered with the Central Purcahse Organisation or the concerned Ministry or Department or Startups as rcognised by Department of Industrial Policy & Promotion (DIPP) in terms of Department of Expenditute (DoE), Ministry of Finance's OM No. F.20/2/2014-PPD (Pt.) dated 25.07.2017. For availing exemption, the concerned firm/agency shall have to submit VALID Registration Certificate with the Tender Document failing which it will not be considered for exemption.

Further, the last date & time for Submission of Tender Document stands revised to 25.08.2021 upto 05:30 PM. The Date, Time and Venue of opening of Tender Document will be 26.08.2021, 11:00 AM and NIIRNCD, Jodhpur-342005 respectively.

All other terms and conditions shall remain the same.
