You are requested to submit your '**Sealed Quotation**' for the above items on or before **14<sup>th</sup>OCTOBER, 2020 by 11.00 A.M.** with the following terms & conditions.

- 1 The quotation for the above items should be addressed to **The Director, ICMR-Regional Medical Research Centre, BRD Medical College Campus, Gorakhpur-273013.**
- 2 The rates of the items may be quoted in Indian Rupees.
- 3 The firm should submit a "**Proprietary Certificate**" on the letter head of the manufacturer firm duly signed with office seal. The proprietary certificate produced by dealer on their letter head will not be valid.
- 4 To enclose a copy of Authorization Certificate / Letter from the Principals, indicating the firm is sole distributor in India for the quoted brand product OR the rate quoted firm is the manufacturer of the product. Conditional quotations are not acceptable.
- 5 The quoted rates of the quotation will be valid for 180 days.
- 6 The quantity of the items may be vary more or less.
- 7 The tenderer should ensure that the item (Consumables) offered fully meet(s) the specifications laid down by the Institute. If at any stage (even after placement of order) it is noted that the item (consumables) offered does not meet the specifications. The Director, RMRC, Gorakhpur reserves the right to take any decision including cancellation of the offer/Purchase Order, etc.



- 8 Tender/Quotation should be preferably, typewritten and every correction in the quotation/tender should invariably be signed by the tenderer, failing which, the tender is liable to be rejected.
- 9 Statutory levies and duties quoted in purchase order will be final and if any change, over and above the rates quoted in our Purchase Order will be borne by the tenderer. The Institute shall not extend validity period for any reason and it will not bind the Institute for receiving the supplies beyond the date specified in the Purchase Order.
- 10 Acceptance process of the item (consumables) supplied will be considered complete after successful inspection of the item at RMRC, Gorakhpur, duly certified as such by the user and countersigned by the Laboratory-in-Charge.
- 11 All damaged, unapproved or defective items shall be replaced by the Vendor at its own cost immediately. Any incidental expenses incurred by the Institute thereon shall be recovered from the Vendor.
- 12 Payment will be made through PFMS / RTGS only after the complete receipt of consignment product in full which will be released after receiving the complete ordered items satisfactory.
- 13 The Vendors may be asked for submission of the sample & required certification of the quoted product before finalisation of the item.
- 14 Delivery Period shall be of two weeks from the date of issuing Purchase Order.
- 15 The quotation received after the due date and time will not be accepted.
- 16 Liquidated Damages @ 1% of the total Purchase Order value, per week will be levied on the vendor for delay in supplies at ICMR-RMRC, Gorakhpur from the original delivery date given in the Purchase order submitted to maximum liquidated Damages of 5%, beyond which the Purchase Order may be cancelled in Toto without any financial liability on the part of RMRC, GKP. The liquidated damages so levied will be recovered from the vendor. For calculation of the LD any fraction of the week (i.e less than seven days) will be considered as a week.
- 17 The name of the subject items should be **"Superscribed on the envelope with due date"** and sent in a sealed cover to the above-mentioned address either personally or by registered post.
- 18 The Director, ICMR-Regional Medical Research Centre, Gorakhpur, reserves the right to reject any or all the quotations without assigning any reason thereof.
