Terms & Conditions for Internal pipeline fittings in ICMR Canteen for PNG connection

- 1. 10% performance security shall be deposited by the Vendor in the form of an Account Payee Demand Draft favoring DG, ICMR. Performance security should remain valid for a period of three months beyond the date of completion of the work.
- 2. 2.5% earnest money of the estimated cost shall be deposited with the Tender by Demand Draft in favour of Director General, ICMR, New Delhi.
- 3. EMD of 2.5% shall be refunded to all the bidders, but for successful bidder only on receipt of Performance Security.
- 4. No advance shall be paid. Payment will be made against satisfactory completion of work.
- 5. The material equipment shall be ISI Mark/IGL approved and best qualaity available in the Market.
- 6. Defect liability period is six months. The Vendor shall submit all the checked bills.
- 7. Taxes and levies as per Govt. rates shall be reimbursable. Hence, Vendors may quote without GST/Levie.
- 8. After completion of the work, the Vendor shall prepare and submit the bill well in time and same will be verified and checked by ICMR. Any correction on the bills should be accepted by the Vendor. However, during the verification, representative of the Vendor shall be called. If the Vendor fails to attend, it will be presumed that he has nothing to say.
- 9. The quantity given in the BOQ are tentative and shall vary as per actual requirement. The quoted rates shall be applied in all such cases. The rates shall be quote both in numerical and words. If there is any difference between the both, the lowest shall be considered.
