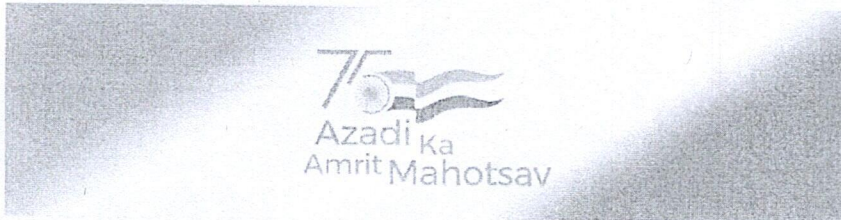

Respected Sir / Madam,

Department of Pension & Pensioners' Welfare's introduced IT system 'Bhavishya' to overcome the problems of delay & clerical errors in processing the pension cases and has greatly facilitated timely sanction and disbursement of pension to retiring employees. The Department regularly monitors the status of processing of pension cases of all central government civil retirees under the said system. In this regard, it is observed that some of the Government servants in various Ministries/Department are not receiving pension or provisional pension on time after superannuation due to the delay in updation of their service verification. In the absence of service verification of the Government servants, a large number of PPOs have been generated in the Bhavishya portal and showing as pending.

2. The rule 30 of the CCS (Pension) Rules, 2021 provides that *on each occasion after a Government servant has completed eighteen years of service and on his being left with five years of service before the date of superannuation, the Head of Office in consultation with Accounts Officer shall, in accordance with the rules for the time being in force, verify the service rendered by such a Government servant, determine the qualifying service and communicate to him, in Format 4, the period of qualifying service so determined.* Further a detailed report of the service verification certificates issued and the reasons for not issuing the said certificate in the remaining cases, needs to be submitted to the Secretary of the Administrative Ministry/Department on each year.

3. In addition to this, DoPT vide their OM No. 21/05/2022-CS.I(Coord.) dated 23.08.2023 (copy enclosed) has issued instructions for integration of applications like PFMS, e-office, Bhavishya etc. and making adoption of eHRMS mandatory in respect of service matter of all Central Government servants. All the Nodal Offices have been instructed to update status in the profiles of Government Servants after their promotion, transfer, training, long leave, deputation and study leave etc. in eHRMS portal.

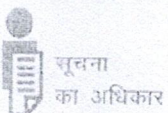

Therefore, it may kindly be ensured for verification of service records of all Central civil Government servants as per the provisions of the CCS (Pension) Rules, 2021 and special efforts may be initiated to complete the service verification of those Central civil Government servants in the e-HRMS who are going to superannuate within a period of two years so that their cases are updated and uploaded in the BHAVISHYA portal for smooth processing and payment of pension timely.

Subject: Updating profiles of Officers of CSS on e-HRMS-2.0 portal-reg.

Reference is invited to this Departments OM of even number dated 17.06.2022, OM NO. 21/04/2022 (CSCMS) dated 15.11/2022 and OM No. 21/01/2023 –CS.I (U), dated 18.01.2023 wherein all the Nodal Offices were instructed to update status in the profiles of Officers after their promotion, transfer, training, long leave, deputation and study leave etc. in eHRMS portal so as to get up-to-date information of incumbency of grades in the cadres, date of postings, promotions, transfers, deputations etc. of the officers to facilitate providing cadre related services.

2. It has been observed that recently a large number of officers various in various grades have been promoted and transfer orders have also been issued in different grades of CSS by the CS.I Division, but the status of these transfers has not been updated by the nodal officers concerned on the e-HRMS 2.0 portal. In the absence of updated profiles of Officers, CS.I Division is unable to identify the exact incumbency status of officers in various cadre units and also facing problem for proper deployment of Officers. All the Nodal Officers are hereby directed to ensure updation of the changes taking place in the service particulars of the officers of CSS by September 1, 2023, failing which action as appropriate shall be taken against the Nodal Officers. A compliance report on updation of information may be sent to this Department at email ID krishnandan.k@gov.in.
