### **A. The mandate of MDMS is as follows:**

1. To foster development of indigenous Medical Device & Diagnostic technology/product (s) in synergies with National Health Mission (NHM), Ayushman Bharat, Health and Wellness centres.
2. To facilitate capacity building through its BioDesign programs and setting-up nation-wide Centers of Excellence for fostering *Make-in-India* product development in the Medical Device & Diagnostic sector.
3. To facilitate preclinical, clinical studies & regulatory compliance of the technologies supported under ICMR-MDMS.
4. To facilitate Health Technology Assessment (HTA) & Field validation for evaluating feasibility of product for potential deployment in public health programs.
5. I.P. Management including Streamlining & Techno Legal support to ICMR HQ and its 27 Institutes (MoAs), online system development etc.
6. IP & Tech Transfer Management of technologies supported by ICMR.
7. Management of National & International Project Collaborations (MoAs).
8. Drafting Guidelines & Policies, as directed by the Competent Authority.
9. Managing Capacity Building exhibitions as directed by the Competent Authority.
