# Record of discussion of the Meeting taken by HFM with Senior Officers at 5.00 P.M. on 6<sup>th</sup> March, 2023.

A meeting of the Senior Officers was held under the Chairmanship of Hon'ble HFM on 6<sup>th</sup> March, 2023 in the presence of Advisor (Health), NITI Ayog. Senior Officers from DoHFW, DHR, NHA, CEO (FSSAI), Chairperson (NMC), President, MARB(NMC) and Director (AIIMS), Delhi were present.

2. AS(LA) made a brief presentation on venue details and gift options in connection with the second Health Working Group meeting of G-20 at Goa.

AS(LA) also made another presentation 'Celebrating 9 years of Transforming Healthcare in India'. A preliminary list of topics for media campaign were proposed and all concerned officers were requested to prepare a write-up on the topics they propose to include in the coverage .

HFM directed to bring out a series at least for a month on the success stories of Health Sector during the time of the present Government since 2014 and directed at least 100 articles may be listed out & prepared by the concerned Officers by next week. ADG (Media) has been asked to coordinate the activity.

- 3. JS(VC) informed that all the States are doing branding of HWCs as per guidelines and about 64,000 photos are uploaded on the portal.
- 4. The issue of finalization of name of RHTC Najafgarh 100 Bedded Hospital came for a discussion. HFM desired that the existing name of the center may continue.

5. On a proposal for establishment of a Paramedical Institute or a Satellite Center of RIPANS in Arunachal Pradesh, HFM opined that a Paramedical Institute may be established. It was also felt that such an Institute may also organize country specific training/courses.

Director (AIIMS) Delhi apprised that in view of acute shortage of beds at AIIMS and other Central Government Hospitals in Delhi, they are in talks with the State Government and NDMC Hospitals to utilize their vacant beds so that emergency patients after being stabilized in AIIMS can be accommodated at those

hospitals. He further apprised that if the patient requires tertiary Care subsequently, he/she would be brought back to AIIMS for management. HFM felt thatsuch a tie-up can be taken forward.

8. Advisor(Cost) informed that comments of NITI on Drugs and Cosmetics Bill have been received which are required to be responded. HFM directed that the matter may be discussed with Member (Health) NITI and finalize the response by Friday(10<sup>th</sup> March, 2023).
