Subject:- Issue of Pension slip by Pension Disbursing Banks on monthly basis.

In order to ensure "Ease of Living" of the Pensioners, a meeting was held with the CPPCs of Pension Disbursing Banks on 15.06.2021, wherein the issue of providing the breakup of monthly pension to the pensioners was discussed. The banks were impressed upon to undertake this welfare measure, as this information is required by pensioners in connection with Income Tax, Dearness Relief payment, DR arrears etc. The banks welcomed the idea and expressed their willingness to provide the information.

2. Accordingly, the undersigned is directed to request all Pension Disbursing Banks to issue pension slip to pensioners after credit of pension on their registered mobile numbers through SMS and email (wherever available) also. Banks may also use social media apps whatsapp etc in addition to sms and email. **The pension slip should provide complete details of monthly pension paid along with break-up of the amount credited and tax deductions etc. if any.**

3. The CPPCs of Pension Disbursing Banks are requested to ensure compliance of the above instructions for improving the "Ease of Living" for pensioners.

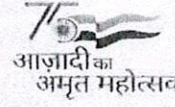


which was being done by various industries in an unorganised manner. Due to lack of transparency and fairness in discovery of scrap price, anti social activities emerged in the sector, thereby exploiting local industries to sell at non competitive prices. To end this unfair practice of the scrap dealers and to give a fair chance to genuine scrap traders and end users, it was decided by OI DC to make the process electronically driven and they appointed MSTC as e-Auction service provider. The process involved signing of Tripartite Agreements between MSTC, OI DC & the Sellers (Industries). OI DC acts as a facilitator and aggregator for the industries. MSTC conducts the e-auctions and collects entire payment on behalf of the Seller alongwith GST and other taxes, if any. MSTC transfers the payments to Seller after deducting the service charge of MSTC and OI DC. OI DC raises invoice to claim its service charge from MSTC. Sellers deliver the material as per the Delivery Orders issued by MSTC and issue invoices to the buyers. - **Minor Mineral Block Auction:** Auction platform used by various States to allot Minor Mineral blocks by two stage bidding method consisting Technical cum IPO followed by forward auction.
- **RCC/ERCC E-Auction:** This portal is for conducting auction for selection of agency for royalty collection from the mining operations.
- **Coal Auction:** Spot & Forward e-Auction sale of coal from Coal India Limited and its subsidiaries by Price-cum-quantity bidding.
- **Iron Ore:** Auction platform for sale of Iron Ore from Karnataka, Odisha, Chhattisgarh etc.
- **Iron Ore Slimes:** MSTC is in advanced stage of empanelling buyers and conducting auction among the empanelled buyers for sale of iron ore slime.
- **Coal Linkage:** This e-bidding platform is for allocation of coal linkages by Subsidiaries of Coal India and The Singareni Collieries Company Limited to non-regulated sectors namely sponge iron/steel, cement, CPPs (captive power plants) and others. The allocation is done through 'Simultaneous Multiple Round Ascending (SMRA) Auctions'. - **Real Estate & Assets**
 - **e-Bikray Auctions:** This e-Auction platform of MSTC has been integrated with the Indian Banks Auction Properties Information (IBAPI) portal (<https://ibapi.in>) so that the prospective bidders have the facility to get all available information at one place and have one uniform system of bidding for all banks. Banks upload all NPA details in IBAPI portal, which is fetched by MSTC for conducting auctions. Interested bidders can register in MSTC's portal and participate in the properties or their interest after fulfilling necessary requirements.
 - **Property portal:** This bidding platform is used by various organisations / authorities like Air India, NBCC, HMDA (Hyderabad Metropolitan Development Authority), DRT, Municipal Corporations, various Port Trusts, etc to conduct e-auctions for selling or leasing plots, commercial spaces. This portal is also used by LD Court Receiver, Supreme Court of India for sale of attached moveable & immovable properties of Amrapali Group.
- **Agricultural / Forest Produces**
 - **Forest Produces:** For sale of timbers, sandal wood, other forest produces Kerala Forest Department and Karnataka Forest Department conduct online auctions through this platform. The traders as well as the individual buyers can participate to buy timbers through this portal.

- **E-RaKAM:** A digital initiative and joint venture between MSTC and CRWC to bring together the farmers, civil supplies and buyers on a single platform to ease the selling and buying process of Agri/Horti produces. The main objectives of this portal are (i) to leverage technology to connect farmers of the smallest villages to the biggest markets through internet, (ii) to make the niche produces available to the consumers across the country / globe, (iii) to generate demand for the niche Agri/Horti produces, (iv) to develop a direct network between the producers and end consumers as well as processing industries. The sellers are individual farmers, FPOs as well as institutions like NAFED, HAFED etc. and the bidders are individuals, various processing units, retailers as well as traders. The Agri/Horti produces like Food Grains, Pulses, Oils Seeds, Spices, Fruits, etc. have been successfully auctioned through this portal.
- **E-Sale of Duty Credit Scrip:**
The Duty Credit Scrip issued to the exporters by DGFT under Service Exports from India Scheme (SEIS) is used for payment of import duties. The duty Credit Scrip is transferable and therefore the unutilised scrip is sold to the interested importers against some value. This bidding platform is used to conduct forward auction to sell the scrip.

e-Procurement:

MSTC's e-procurement service includes offering the bidding portal for procuring/buying goods & services, finalising project/EPC contracts, Import of Coal, fund mobilisation (borrowing & deposit placement) as well as various customised solutions as per the requirements of the clients. This platform can be configured to accommodate various customised solutions. It has the feature to reach the target groups.

In order to promote air connectivity between the smaller cities / towns with bigger cities, Government of India has devised a Scheme for providing financial subsidy to interested airline operators who will operate to connect the underserved / unserved airports. The government has earmarked a fund called Regional Connectivity Fund (RCF) to finance the gap which is also called Viability Gap Funding (VGF). The Scheme is known as Regional Connectivity Scheme (RCS).

This online platform manages the bidding process to create various networks by connecting various unserved, underserved & the key airports as well as disbursement of the VGF. Swiss Challenge bidding method is used to determine the least VGF and select the airline operators for various networks created through this platform.
- **DEEP Portal:**

This portal namely Discovery of Efficient Electricity Price (DEEP) has been developed as per the guidelines Under Section 63 of the Electricity Act 2003, Government of India, for procurement of power by distribution licensee for Short term, medium term & long term through a competitive bidding process. All the Generators, Traders, Licensees and other Distribution Companies having surplus power can register themselves with the e-platform as Bidders. The power procurers are allowed to raise their indents on the website and create e-bidding events for interested bidders to participate in the bidding process. The e-bidding process is carried out in two stages namely RFP stage and e-reverse auction stage.
- **Renewable Energy:**

This e-bidding platform is developed to select EPC contractors for renewable energy projects. The mode of bidding is e-tender followed by Reverse auction and L1 matching. Subsequently bucket filling approach is adopted for allocation of the contracts.
- **Transmission Service Provider:**

As per Government of India guidelines the process of selection of transmission service providers for electricity transmission services, the new transmission projects are offered to the interested agencies on BOOT model.

- **DIPAM:**
This electronic bidding system is developed for the Department of Investment & Public Asset Management, Government of India, for Asset Monetisation.
- **Javik Kheti portal (jaivikkheti.in):**
For providing direct access to the market for organic farmers, on behalf of Ministry of Agriculture MSTC has developed the portal. This portal provides a single window for creating general awareness & knowledge sharing on Organic Farming, developing network between the Farmers, Buyers & Input Suppliers and also transacting business online with e-payment & logistic support.
- **Export & Import Portal:**
