

Sub: Fire safety measures in ICMR HQ, New Delhi.

As you are aware that a fire fighting training, power point presentation followed by mock drill of fire safety measures was conducted on 20-12-2019 in ICMR HQ Building by CPWD Safdarjung Hospital Electrical Division, New Delhi, in which approximately 113 persons from different Divisions/Sections/Units had actively participated.

- 2. All concerned Divisions/Sections/Units are requested for strict compliance of following fire preventive measures in their respective Offices/Sections/Units-
- Before leaving the office UPS shall be shut down.

Before leaving the office all electrical appliances shall be switched off.

Near and above the electrical appliances/UPS, no files/papers etc. shall be stored/placed.

The Security Supervisor is instructed to check that all points marked above under Para 1 to 3 are properly complied before locking the room every day.

Extension boards shall be not be used, if using, it shall be reported to maintenance section of ICMR for replacement by suitable points.

Maintenance section shall be reported immediately if there is found that electrical appliances are getting heated.

The Admin I is requested to ensure that the Security persons working in ICMP are trained in fire fighting.

The use of certain electrical appliances is already banned in ICMR like Heater, incrowave oven etc. The Security supervisor may be requested to ensure the compliance of same.
