As you would be aware, the Ministry of MSME, Government of India launched "MSME SAMBANDH" portal on 8th December, 2017 to ensure close monitoring of procurement by the Central Ministries/ Departments/ CPSEs and to provide a platform to upload their annual and monthly procurement data and other details. This portal can be accessed through the link <http://sambandh.msme.gov.in> and the user manual along with respective user ID/ Password had been communicated to all Central Ministries/ Departments/ /CPSEs to access the "MSME SAMBANDH" portal.

2. All Central Ministries/ Departments/ /CPSEs were requested to upload their annual and monthly procurement data of goods and services procured from MSEs as well as MSEs owned by SC/ST/Women entrepreneurs on the portal. However, it has been observed many Ministries/Departments have not been updating their procurement data on the portal regularly.

3. In this context, you are requested to ensure that the procurement data pertaining to your Ministry/ Department for the past financial Years is uploaded in the "MSME SAMBANDH" portal as per the format given in the portal.
