

Dear Secretary



As you are aware, Government of India has created a separate Ministry of Cooperation to focus on the development of cooperative sector.

2. There are more than 8.5 lakh cooperatives in India as per statistical profile of Indian Cooperatives, 2018, published by the National Cooperative Union of India (NCUI). The cooperatives have a very significant presence in sectors like dairy, housing, fisheries, livestock and poultry, handloom, agro-processing, women cooperatives, service cooperatives, SC-ST cooperatives, etc.

3. During the recent Budget Webinar organized by Ministry of Agriculture & Farmers Welfare, Prime Minister observed that all out efforts should be made to leverage the strength of the cooperatives and transform them into successful and vibrant business enterprises. This would require that cooperatives be integrated with the existing Schemes and Programmes of different Ministries and Departments. Also, it should be ensured that they are treated at par with other forms of economic entities, both as beneficiaries and participants.

4. Further, Ministry of Cooperation can be given due representation in different implementation committees of Ministries / Departments so that the concerns of cooperative sector can be appropriately addressed in these fora.

5. The requirement for education and training in this regard can be met through various institutes of Cooperative Management and Training, in consultation with Ministry of Cooperation.

6. I would request that necessary action may kindly be taken in this regard and Ministry of Cooperation may be kept informed.
