The Indian National Flag is a symbol of national pride for the entire nation. To further honour our flag, National Implementation Committee (NIC) headed by the Hon'ble Home Minister which oversees all efforts under Azadi ka Amrit Mahotsav, has approved the programme 'Har Ghar Jhanda'. It envisages inspiring Indians everywhere to hoist the national flag at their home. The idea behind the initiative is to invoke a feeling of patriotism in the hearts of people and promote awareness about our national flag.

- It is to inform you that the category of "The Indian National Flag" in various sizes as per BIS 2. specification IS:1 is already available on GeM. Various manufacturers, including KVIC, have already uploaded their products in this category. GeM is separately advising the sellers to keep sufficient stock for meeting any requirement of the Government buyers.
- In addition, Demand Aggregation functionality is already live on GeM. Any Ministry can club the 3. requirements of all its departments to procure in bulk to achieve economies of scale.
- It is requested kindly to issue necessary instructions in your Ministry to procure the National Flag through GeM only. Please let me know if any assistance is required for procurement of this item on GeM.
