Dear Secretary,

As you are aware that in line with Digital India Mission and as a part of its mandate to conduct Govt. litigation, the Department of Legal Affairs (Ministry of Law & Justice) has in association with National Informatics Centre implemented the Legal Information Management and Briefing System (LIMBS), a web based application to monitor Govt. Litigation in various Courts and Tribunals in a proactive, transparent and effective manner.

2. I would like to take this opportunity to appreciate the efforts made by all the Ministries/Departments in bringing all the litigation matters on a digital platform. With the concerted efforts from all the User Ministries/Departments, LIMBS as on date has a unified database of 8.26 lakh court cases (including archive cases), 14204 registered users and more than 21000 advocates.


3. I may like to draw your kind attention that the entry of cases on the LIMBS portal is a continuous and dynamic process and maintaining the factual accuracy of the data from time to time is of prime importance. It is emphasized that LIMBS application can be best utilized only when all the Ministries/Departments enter all court cases in which they are a party with complete information in the relevant fields. Therefore, the exercise of entry of all the court cases by the concerned users of Ministry/Department needs to be completed in time bound manner and periodically reviewed by nodal officers as requested earlier in past.

4. I shall be grateful if you kindly direct all the concerned users to complete the entry of all the Court Cases in LIMBS application pertaining to your Ministry/Department/Attached offices in a time bound manner and submit a status report to this Department latest by 15.06.2022 on [admn4la-mol@nic.in](mailto:admn4la-mol@nic.in). In the absence of such report the Department of Legal Affairs may not be in a position to process proposals for legal advice/payment of advocate fees in respect of any case of Union of India which is not entered on LIMBS and in respect of those Ministries/Departments from which status report is not received by the date indicated above.

Your earnest cooperation in this regard is solicited.
