## Office Memorandum

Subject: Increasing efficiency in Decision Making in Government - reg.

Government has undertaken various reforms to increase efficiency in decision making in Government including review of channels of submission and delegation of powers, digitization of Central Registration Units (CRUs), adoption of e-office version 7.0 and operationalization of Desk Officer System. These measures are under implementation since March, 2021.

- The reforms undertaken need to be further deepened so as to ensure that they are long lasting. Accordingly, it has been decided that Ministries/Departments may take the following measures:
- Include implementation of reforms and impact thereof as agenda item of Senior Officers Meetings;
- ii. Create a mechanism for encouraging officers/officials to accelerate implementation of these reforms by way of identifying the best performing Divisions/Sections:
- iii. Briefly include the progress of implementation of these reforms in the Monthly D.O. letters to the Cabinet Secretary; and
- İγ. Share their best practices with Department of Administrative Reforms and Public Grievances regularly.
- It has further been decided that Department of Administrative Reforms and Public Grievances will undertake a third party impact evaluation of implementation of these reforms in March, 2022. The schedule for evaluation shall be communicated in due course.
- All Ministries/Departments are requested to take measures mentioned above in a time bound manner and take necessary preparatory steps for the proposed evaluation.
