**Brief about Committee for the Purpose of Control and Supervision of Experiments on Animals (CPCSEA)**

The Committee for the Purpose of Control and Supervision of Experiments on Animals (CPCSEA) is a statutory Committee of Department of Animal Husbandry and Dairying (DAHD), Ministry of Fisheries, Animal Husbandry and Dairying (MoFAH&D) constituted under Chapter 4, Section 15(1) of the Prevention of Cruelty to Animals (PCA) Act, 1960. CPCSEA is duty bound to take all such measures as may be necessary to ensure that animals are not subjected to unnecessary pain or suffering before, during or after performance of experiments on them. For this purpose, the Committee formulated the "Breeding of and Experiments on Animals (Control & Supervision) Rules, 1998" (amended in 2001 & 2006) to regulate the experimentation on animals. Under the provisions of the above rules, establishments who are engaged in Bio-medical research, breeding and trading of laboratory animals are required to get themselves registered with CPCSEA. Till date 1813 establishments are registered with CPCSEA. The following are the mandates of the Committee:

- i. Registration of establishments engaged in Experiments, Breeding and Trading of Laboratory animals.
  - ii. Constitution of Institutional Animals Ethics Committees (IAECs) in the establishments registered with CPCSEA.
  - iii. Approval of Animal House Facilities for Small and Large animals.
  - iv. Permission for conducting experiments on Large Animals.
2. The Members of the Committee are eminent scientists and professors from the field of Veterinary Sciences, Biotechnology, Biochemistry, Biostatistics, Pharmaceutical Science, Medicine, Animal Ethics, Life Sciences and Animal behaviour etc. and having adequate experience in handling and welfare of Laboratory animals.
3. Apart from the technical experts, Joint Secretary (Animal Welfare) is the Chairman of CPCSEA and Joint Commissioner (Animal Welfare) is the Member Secretary of CPCSEA. The constitution of the Committee under the above mentioned categories is finalised at the level of Hon'ble Minister of Fisheries, Animal Husbandry & Dairying.
4. The present Committee has been re-constituted vide the Gazette Notification S.O. 4595(E) dated 2nd November, 2021, for a period of three years, with 19 members wherein Dr. O. P. Chaudhary, Joint Secretary (Animal Welfare) is the Chairman of CPCSEA and Dr. S. K. Dutta, Joint Commissioner (Animal Welfare) is the Member Secretary of CPCSEA.
