Filling up of the post of Registrar in the IIMC.

Indian Institute of Mass Communication which is an Autonomous Society under the Ministry of Information & Broadcasting, Government of India proposes to fill up its vacant post of Registrar on deputation basis. The post is in Level 13 of the Pay Matrix as per 7th CPC (Rs.1,23,100-2,15,900).
