II. Diploma in Computer Applications from a recognised University or Institute.

Note 2: For purposes of appointment on the deputation or absorption basis, the service rendered on a regular basis by an officer prior to 1st January, 2006 or the date from which the revised pay structure based on the sixth Central Pay Commission recommendations has been extended, shall be deemed to be service rendered in the corresponding grade pay or pay scale extended based on the recommendations of the Commission except where there has been merger or more than one pre-revised scale of pay into one grade with a common grade pay or pay scale, and where the benefit will extend only for the post(s) which that grade pay or pay scale is the normal replacement grade without any up-gradation.

Note 3: The departmental officer in the feeder category who are in direct line of promotion shall not be eligible for consideration for appointment on deputation. Similarly, deputationists shall not be eligible for consideration for appointment by promotion.

Note.4: Only Central Government or State Government employees are eligible for consideration for appointment on absorption basis (if applicable).

- The officers selected for appointment on deputation (istc) basis shall be entitled to draw pay/ pension (duty) allowance in accordance with the existing instructions on the subject issued 2. by the Government of India from time to time.
