Sub: Call for proposal for procurement of equipments, goods and services costing Rs. 25 Lakhs to 1 Crore and above under CPC, ICMR Hqrs.

The Central Procurement Cell (CPC) at ICMR Hqrs. is mandated for the procurement of equipments, goods and services costing Rs. 25 Lakhs to 1 Crore and above for its 27 national and regional institutions across the country and the divisions at ICMR Hqrs.

The last call for proposal was initiated March/April, 2021 and the proposals received till April 30th, 2021 were considered and processed procurement which is expected to be complete by October/November, 2021.

It has now been decided that the call for proposal for the procurement of equipments, goods and services under the CPC is to be floated twice in a year (i.e. in March/April and September/October) during each financial.

As indicated above, the next cycle of call for proposal for procurement of equipments, goods and services costing Rs. 25 Lakhs to 1 Crore and above in the current financial year is as under:

SCHEDULE FOR SUBMISSION OF THE PROPOSALS:

- Last date for submission by the Institutes to their respective Technical/Administrative Division: **04.10.2021**.
- Last date for forwarding the proposals by the Technical/Administrative division to Central Procurement Cell (CPC): 11.10.2021.

• INSTRUCTIONS FOR SUBMISSION OF THE PROPOSALS:

- 1. All proposals are to be submitted by the institutes to their respective Technical/Administrative Division at ICMR Hqr. with copy (CC) to CPC at e-mail Id: cpcicmr@gmail.com.
- 2. Proposal for each type of equipments, goods and services is to be submitted separately enclosing all the requisite documents.
- 3. All proposals should contain copies of SAC recommendations/approval, Institute Technical Specification Committee (ITSC) recommendations along with the detailed approved specifications by ITSC duly approved by the Director of the Institute.
- 4. For any proposal to be considered under "Buy-Back Offer"/Category, a separate proposal is to be submitted for each of such equipments as per the GFR 2017 rule 176 providing the requisite details of such equipments required for tendering process.
- 5. In case of any proposal having "**urgency**" of the required equipments, goods and services, the institutes should indicate the urgency with justification and putting a grade on it.
- 6. The entire proposals are to be processed by the respective Technical/Administrative Division through proper channel and forwarded to CPC on or before the last date of submission.
- 7. No proposal will be considered if received after the last date of submission.
