The undersigned is directed to say that this Ministry desires to fill up a post of John Director (Production/Princings, Publicity) (General Central service, Group A', Gazetted, Non-ministerial in the Pag Matrix Level-12 as per 7th CPC recommendation (Pre-revised pay scale of PB-3 + G.P. Rs.7600)) in the Common Cadre of Art & Production Staff of BOC (DAVP) & DPD, subordinate offices under this Ministry by transfer on deputation basis. The terms and conditions for the appointment to the post of Joint Director (Printed Publicity/Production) are mentioned in Annexure I.

- The period of deputation will be initially for a period of one year which may be extended at the discretion of the appointing authority. However, the period of deputation including period of deputation, in another ex-cadre post held immediately preceding this appointment in the same or some other Organisation/Department of the Cookal Government, shall ordinarily not exceed 7 years. 
