Dear Secretary

As you are aware, Public Procurement (Preference to Make in India) Order, 2017 (PPP-MII Order, 2017) was issued by the Department for Promotion of Industry and Internal Trade (DPIIT) to encourage 'Make in India' and promote manufacturing and production of goods, services and works in India, with a view to enhancing income and employment.

2. This policy is applicable to all Ministries / Departments / attached / subordinate offices / autonomous bodies under the Government of India and includes Government companies as defined in the Companies Act.

3. It has been observed from the tenders issued by various procuring entities on CPP / GeM portals that PPP-MII Order is not being implemented in letter and spirit by some of the organisations. There are instances where the provisions of PPP-MII Order have not been incorporated in the tender. Excessive turnover, requirement of specific brands / makes, requirement of foreign certification, requirement of unreasonable prior experience, and requirement of prior experience of supplying to specific nations / entities have sometimes been prescribed as qualifying criteria.

4. In view of the above, you are requested to advise all the procuring entities under your Ministry / Department to ensure full compliance of PPP-MII Order, 2017 in letter and spirit. You are also requested to kindly review the implementation of the order and take all necessary measures / corrective actions, so that there is no deviation from the PPP-MII Order, 2017.
