OFFICE MEMORANDUM

Subject:- Filling up of the post of Deputy Director of Estates(Office & Market)(ex-cadre) on deputation basis in the Directorate of Estates, Ministry of Housing and Urban Affairs -- reg.

The undersigned is directed to say that one post of Deputy Director (Office & Market), a General Central Service, Group-A (Gazetted) in Level-11 in the Pay Matrix (pre-revised pay scale is Pay Band-3 (15600-39100) plus Grade Pay of Rs.6600/-) is proposed to be filled up on deputation basis in the Directorate of Estates.

2. The eligibility criteria for the above post to be filled up on deputation basis is as under:

- i) Central or State Government Officers holding analogous posts; or
- ii) With 5 years' service in the posts in Pay Band-3 (Rs. 15600-39100) plus Grade Pay of Rs.5400/- (Revised Pay Level-10 in the Pay Matrix) or equivalent or;
- iii) With 8 years, service in the post in Pay Band-2 (Rs. 9300-34800) plus Grade Pay of Rs.4800/- (Revised Pay Level - 8 in the Pay Matrix) or equivalent;






