

The Undersigned is directed to say that in accordance with the Cabinet decision in the matter, Secretaries in the Union Ministries of Home Affairs, Health and Family Welfare & Human Resources Development were requested, vide Secretary (P)'s D.O letter of even number dated 30th August, 2007 to issue necessary guidelines to the State Government/UT Administrations for implementation of the above action points. Accordingly, Ministry of Health and Family Welfare had issued necessary instructions vide D.O letter No.A-23011/2/2007-Ply dated the 19th September, 2007(Copy enclosed).

2. In the Review Meeting of Nodal Officers taken by Secretary Ministry of Minoroty Affairs on 06.01.2012, it was decided to request the concerned Ministries viz. Ministry of Home Affairs, Ministry of Human Resource Development and Ministry of Health and Family Welfare to reiterate their instructions for posting of Muslim personnel in Thanas, Schools and Health Centre. Accordingly, it is requested that the Ministry of Health and Family Welfare may reiterate the instructions to all concerned for posting of Muslim personnel in Health Centre in Muslim concentration areas under intimation to this Department and the Ministry of Minoroty Affairs.




