Subject: Filling up the post of Assistant Secretary in the Foundation.

Sir.

Applications are invited for selection of suitable persons for two posts of Assistant Secretary in the Foundation in Pay Band 2 Rs.9,300-34,800 plus Grade Pay of Rs.4,800 on the basis of (a) deputation, (b) re-employment after retirement or (c) contract.

The Terms of appointment and fixation of pay to the aforementioned posts, under any category, will be regulated as follows:

(i) Deputation: The period of deputation and fixation of pay of the incumbent will be governed in accordance with the provisions of Department of Personnel & Training O.M. No.2/29/91-Estt. (Pay II) dated 5<sup>th</sup> January 1994, as amended from time to time. However, initially the period of deputation will be for one year only which may be extended further as per rules. The age of the applicant should not be more than 55 years as on 01.11.2010.

Re-employment: The retired/retiring persons should not be more than 62 years of age as on 01.11.2010. Initially the persons selected will be appointed for one year only and the tenure of appointment may be extended upto attaining the age of 65 years on requirement basis. The remuneration on re-employment will be regulated in accordance with the provisions of Department of Personnel & Training O.M. No.3/1/85-Estt. (P.II) dated 31.07.1986 as amended from time to time, subject to a maximum consolidated monthly remuneration of Rs.25,000 without any kind of allowance or annual increment.

(iii) Contract: The persons applying for the posts on contract basis from open market should not be more than 35 years of age as on 01.11.2010. Initially the persons will be appointed for a period of one year, which may further be extended on the basis of exceptional performance. The remuneration of persons recruited on contract basis will be fixed between Rs.20,000 and 25,000 with annual increment of Rs.1,000 without any other allowance.
