



Subject: Revised Special Allowances of Non-Statutory Departmental Canteen employees consequent upon the recommendations of the VIth Central Pay Commission

The undersigned is directed to state that the Government's decision, on the recommendations of Sixth Central Pay Commission relating to Canteen Staff in "Miscellaneous Allowance" in Para 4.2.81 of its report contained in part -B, notified, vide Ministry of Finance, Deptt of Expenditure Resolution No.1/1/2008- I.C. dated 29th August, 2008 has been considered in consultation with Ministry of Finance and it has been decided to revise the special allowance by doubling the extant rates of special allowance, admissible to certain categories of Canteen employees i.e. General Manager, Deputy General Manager, Manager Grade-II, Manager-cum-Accountant, Assistant Manager-cum-Storekeeper at the following rates :
