 - (iv) Cadre clearance in respect of the officer.

- 4. Applications received after the closing date of receipt of applications or without the CR dossiers (or photocopies of CRs) or otherwise found incomplete are liable to be rejected. Officers who apply for the posts will not be allowed to withdraw their candidature subsequently. While forwarding the application, it may be verified and certified that the particulars furnished by the officer are correct.
