The undersigned is directed to invite attention to this Unit's O.M. of even number, dated the 29th April, 2009, on the above noted subject, calling upon all Units/Sections/Divisions to furnish monthly report of all courts cases being handled/to be handled by them in prescribed proforma. This exercise has been undertaken in order to comply with the directions of the Ministry of Finance, Department of Expenditure vide DO No.223/E.IV/08 dated 9.2.09, circulated by Internal Finance Division of this Ministry vide O.M. No.28-7/2009-IFD, dated 16..2.09, which make it incumbent upon all the Departments/Ministries to regularly monitor all Tribunal/Court cases particularly those in which the Ministry of Finance, the Department of Expenditure, has been named one of the respondents and pay due attention to the time lines. This is with the view that where required, consultation with the Ministry of Finance may be made within the stipulated time frames.

However, reports being received from various sections/sub-ordinate offices in detail which contain information of all the court cases being handled by them irrespective of whether the Ministry of Finance are party to the case or not. This results in unnecessary paper work and makes effective monitoring of such cases that more difficult. With a view to facilitate better and effective monitoring of such cases as also to reduce the unnecessary paper work to the minimal, it has been decided that those court cases in which Ministry of Finance has either been named as one of the respondents or has been consulted even though it may not be party to the case, may be reported in detail. In respect other court cases, the status may be furnished in a nutshell to ensure that the Ministry of Finance orders are complied with.
