- 2. The advertised posts are tentative without commitment for its filling.
- 3. Emoluments: The rates of consolidated emoluments shown in this advertisement are project specific and may vary according to qualifications of candidate and sanction by the respective funding agency of the Project
- 4. Cut-off date for age limit will be as on the last date for submission of applications.
- 5. Engagement of successful candidates shall also be decided by the appointing authority at its discretion.
- 6. Qualification & experience should be in relevant discipline/field/ trade and from an accredited/reputed Institution. Experience should have been gained after acquiring the minimum essential qualification.
