Terms & Conditions for the post are as follows:

- 1. The consultants shall not be entitled to any other honorarium or allowance such as Dearness Allowance, Residential Telephone, Transport Facility, Residential Accommodation, Personal Staff, CGHS and Medical Reimbursement etc.
- Consultants shall be eligible for 10 days leave at par to 8 CL & 2 RH in a year on prorata basis. Therefore a Consultant shall not draw any remuneration in case of his/her absence from work beyond 10 days in a year to be calculated on pro-rata basis. Un availed leave during the period of engagement will not be carried forward in case of renewal.
- 3. No TA/DA shall be admissible for joining the assignment or on its completion. However, Consultants shall be allowed TA/DA for their travel inside the country in connection with the official work as per his/her entitlement at the time of retirement in case of Govt. servant. For external professionals class/mode of journey would be by economy class only as per rules. Consultant will be provided transport facilities for local official duty.
- 4. All applicable taxes as per government rules and regulations will be deducted at source.
