2. Since the posts are purely temporary, the incumbents selected will have no claim for regular appointment in ICMR-NIMS, ICMR-NIRTH or ICMR Hqrs. or any other institute of ICMR.
3. The appointment will be for one-year extendable upto 2 years.
4. The appointment is terminable with one month notice period from either side without assigning any reason.
5. No TA/DA will be paid for attending the interview/written test.
6. Leave shall be as per ICMR rules for project staff.
7. Relaxation for SC/ST/OBC will be as per Govt. of India norms.
8. Qualification and experience should be from a recognised university/organization/institution.
9. Experience should have been gained after acquiring the minimum essential qualification.
