Selection Procedure: The shortlisted candidates will only be called for an Interview. The Interview will be conducted through offline mode at ICMR-Regional Occupational Health Centre (Southern), Bangalore with prior intimation to the candidates.

2. Qualification & experience required are as per guidelines: experience shall be counted after acquiring the essential qualification; age limit and experience will be considered as on the date of the interview.

3. Initially the appointment is for the tenure mentioned in the tables above for the respective post from the date of assignment of duty and is likely to be extended if required subject to performance evaluation by the Project Investigator.

4. Benefits of Provident Fund, CCA, DA, HRA, TA, Leave Travel Concession, Medical claim, leave concession etc. are not admissible. The posts are purely temporary, co-terminate with scheme and the incumbents selected will have no claim for regular appointment/employment under ICMR/ICMR-NIOH-ROHC(S), or continuation in other projects and his/her engagement will be deemed terminated immediately after expiry of the scheme without any notice.

5. Age relaxation will be admissible as per GOI norms. Age concession to the extent of service rendered in other ICMR research projects will also be admissible for experienced and skilled persons.

6. Candidates employed in Govt. Service/ Semi Govt. /Autonomous Bodies of state/ Central Govt. should submit a "No Objection Certificate" from their employer at the time of test/interview.

7. Submission of incorrect or false information during the process of interview or in the application shall disqualify the candidature.

8. Any further information may be downloaded from ICMR-NIOH website i.e. www.nioh.org, which will be updated from time to time. Date of interview may be changed due to administrative reasons, hence candidates are advised to check website before appearing for interview/test.

9. No re-imbusement charges will be paid for application submission or for attending the interview.

10. The decision of the Director/ Director-In-Charge, ICMR-National Institute of Occupational Health, Ahmedabad will be final in this regard.

The certificates will be verified for the selected candidates and after fulfilling the criteria shortlist of candidates will be issued.
