Interested candidates meeting above-mentioned eligibility may appear for the Walk-In- Interview to be held on **25 November, 2022** at National Institute of Medical Statistics (NIMS), ICMR, New Delhi. Eligible candidates must be sent their applications in the prescribed form, duly filled in all respect along with a detailed bio-data/CV and all required supporting documents and certificates, duly **self-attested**. In proof of his/her educational qualifications [all certificates and mark-sheets from 10th Std. onwards], working experience, age, caste certificates (as applicable) and photo id [Aadhar card/ Indian passport/PAN card/driving license] etc. should be sent on the email: **icmrprojectnims@gmail.com** within the scheduled date and time for submission of applications i.e., on or before **November 21, 2022** up to 17.00 hrs., failing which his/her candidature will not be considered. Late/ Delayed/Incomplete/Unsigned applications will not be considered and rejected straight away without any correspondence. Candidates are therefore advised to submit their application well in time without waiting for the last date for submission of application. Candidature of successful candidates shall be subject to verification of all original documents by ICMR-NIMS and fulfillment of required eligibility criteria in all respect of qualifications, age and experience, etc.

Terms and Conditions:

1. The application should be as per the prescribed format (Annexure – A) Candidate should write the Name of the Project on the top of the application.
2. The interested candidates should register themselves for interview by 9.30 AM on 25th November 2022 at NIMS. The walk-in-Interview would be held from 11 AM onwards on 25th November 2022.

3. The Post is to be filled on purely temporary basis. The appointment can be terminated with one month notice from either side without assigning any reason.
4. Since the post is purely temporary, the incumbents selected will have no claim for regular appointments at NIMS or the ICMR or any other institute of the council or continuation of his/her service in any other project. No benefits of provident fund, HRA, Leave Travel Concession, Medical Claim are admissible.
5. Working Station for the above-mentioned post is ICMR-NIMS, New Delhi.
6. It may be mentioned here that incomplete applications, application not submitted in prescribed format and application without supportive documents asked for shall be summarily rejected.
7. Qualification and experience should be in relevant discipline/field and from a reputed Institution / organization recognized by relevant authority.
8. Experience shall be counted from the date of completion of minimum essential educational qualification.
9. Submission of incorrect or false information during the process of selection shall disqualify the candidature at any stage.
10. Age limit and experience will be considered as on the closing date for submission of application (**November 21, 2022**).
11. Mere fulfilling the essential qualification / experience does not guarantee selection.
12. The Director has the right to accept/reject any application without assigning any reason.
13. Age relaxation will be as per the guidelines of ICMR.
14. Candidates already working against regular/permanent posts under government Department/organizations are not eligible to apply.
15. Community/ Caste certificate: Candidates applying under OBC category, shall submit attested copy of OBC Non – Creamy Layer Certificate in specified format as applicable for Govt jobs, issued within one year from the date of submission of application by the appropriate authority. Only Non-Creamy Layer OBC certificates will be accepted and other certificates will not be accepted.
16. There of and no correspondence/recommendation will be entertained in this matter.
17. Canvassing and bringing inside or outside influence in any form for short listing and Employment will be treated as a disqualification and the candidate will be debarred from selection process.
