Terms and Conditions:

- 1. Interested and eligible candidates can appear for walk-in-interview on the date mentioned for the post along with the duly filled in the prescribed application form (attached).
- 2. The Post is to be filled on purely temporary basis. The appointment can be terminated with one month notice from either side without assigning any reason.
- 3. Since the post is purely temporary, the incumbents selected will have no claim for regular appointments at NIMS or the ICMR or any other institute of the council or continuation of his/her service in any other project. No benefits of provident fund, HRA, CCA, Leave Travel Concession, Medical Claim are admissible.
- 4. Working Station for above mentioned post is ICMR-RMRC Gorakhpur. This research position involve in preparation of the study tool, the pilot testing of study tools, identification of potential study participants, study participant's recruitment, data collection and data entry using dedicated data entry software, preliminary analysis.
- 5. Interested candidates meeting above-mentioned eligibility may appear for the Walk-In- Interview to be held on 16th April 2022 at ICMR Regional Medical Research Centre (RMRC), Gorakhpur. Candidates should bring with them application form, detailed Bio-Data along with original certificates of (1) Educational qualification (2) Proof of Date of birth (3) Experience certificates/testimonials (4) One-self attested recent passport size photograph (5) ID Proof (Ex. PAN/Voter ID/Driving License etc.) (6) One set of self-attested photocopies of all documents. (7) SC/ST/OBC/PWD Certificates, if applicable. (8) Candidates should submit all certifications/testimonials in original for verification. Candidates who fail to bring the original certificates will not be entertained to attend Walk In Interview.
- 6. The interested candidates should register themselves for interview by 9 to 11 AM on 16th April 2022 at ICMR Regional Medical Research Centre (RMRC), Gorakhpur. The walk-in-Interview would be held from 11 AM onwards on 16th April 2022.
- 7. Candidates who will report after the scheduled date/time will not be allowed to appear in interview / or personal discussion.
- 8. It may be mentioned here that incomplete applications, application not submitted in prescribed format and application without supportive documents asked for shall be summarily rejected.
- 9. Qualification and experience should be in relevant discipline/field and from a reputed Institution / organization recognized by relevant authority.

- 10. Experience shall be counted from the date of completion of minimum essential educational qualification.
- 11. Submission of incorrect or false information during the process of walk-in- interview shall disqualify the candidature at any stage.
- 12. Age limit and experience will be considered as on the date of walk-in-interview.
- 13. Mere fulfilling the essential qualification / experience does not guarantee selection.
- 14. In case of large number of eligible candidates after scrutiny of applications, a written test may be conducted. The written test shall consist of objective type questions.
- 15. The Director has the right to accept/reject any application without assigning any reason.
