

Candidates will not be entertained after reporting time under any circumstances.** The candidates have to submit application on plain paper along with two copies of their detailed Bio-Data with self-attested copies of the certificates (a) Proof of Date of Birth (b) Qualifications (c) Experience (d) Recent Passport size photograph and testimonials at the time of reporting. The original certificates may be produce for verification on demand. Only shortlisted candidates will be called for walk-in-interview/written test after verification of documents. The walk in Written Test / Interview will be taken in English / Hindi.
2. Age concession to the extent of service rendered in other ICMR research projects will also be admissible for experienced and skilled persons. Age, Qualification, experience etc., will be reckoned as on, the date of walk-in interview.
3. The engagement of above posts will be on temporary basis and the selected candidates shall not have any right to claim for regular appointment under ICMR / NIOH. His/her engagement will be deemed terminated immediately after expiry of this Scheme without any notice and the ICMR-NIOH, Ahmedabad will hold no responsibility for payment of salary/regular appointment etc. thereafter.
5. Since the post is purely temporary, ad-hoc and co-terminate with this Scheme, the candidate will not be entitled to any allowances such as CCA, DA, HRA, TA, Leave Travel Concession, Bonus, Medical Claim, PF etc..
6. Candidates employed in Govt. Service /Semi Govt. /Autonomous Bodies of State/Central Govt. should submit a "No Objection Certificate" from their employer at the time of walk-in written test / Interview.
7. If required, the written examination/test shall be of one (1) hour duration consisting of objective type questions on General Science, General Analytical Ability and knowledge of concerned area.
8. No TA/DA will be paid for attending the written test / interview / personal discussion.
9. Candidates have to bring original ID card and Vaccination certificate while reporting for Interview.
10. Any further information may be downloaded from ICMR-NIOH website, which will be updated from time to time. Date of personal discussion / written test may be changed due to administrative reasons, hence, candidates are advised to check website before appearing for personal discussion / written test.
11. The decision of the Director-in-Charge, ICMR- National Institute of Occupational Health, Ahmedabad will be final in this regard. Canvassing in any form will be considered as a disqualification.
